





#### **Paper Presentation**

Individual or co-authored research papers will be presented. Each presenter will be given ten minutes to present their work and five minutes for discussion/questions. The author/s needs to send an abstract of 500 words and a list of 3-5 keywords.

#### Round Table

The session is proposed to engage administrators, policymakers, legal experts, social scientists, NGOs, and research institutions to discuss issues related to the seminar's theme.

#### **Poster Presentation**

In the session, the authors will explain their poster, which is related to the seminar team, to the circulating audience. Poster can be related to their research work or field work are based on their practical experience with AI. The authors need to send and abstract of 500 words with list of 3-5 keywords.

#### Resource Persons

The persons of judicial, administrative, and academic eminence will chair and co-chair the technical sessions for paper presentations, moderate the round table discussion, make suggestions in the poster presentation, and give the keynote speech in the inaugural and valedictory programmes.

### Call for Paper Submissions

#### Call for Full Academic Paper

Thought provoking and original individual or co-authored research papers giving fresh insights on any one of the seminar's themes or sub-themes are invited from Academicians, Researchers, Legal Practitioners and Law Students to the National Seminar.

#### Paper Submission Guidelines

- The authors are required to identify the broad theme for their proposed research paper, which will help us allocate the subject expert for the review of their research paper.
- An author may write the research paper with a maximum of two co-authors.
- The submitted research papers will be evaluated based on their relevance to the seminar theme and broad topics, originality, policy significance, and engagement with the broader research area of Artificial Intelligence and Law. The papers may be theoretical, applied, or policy-oriented.
- The presented papers will be published as a book with ISBN after the author incorporates the suggestions/changes suggested during the discussion/ questions session and submits the copyright Declaration Form.
- Other than paper presenters, any other research scholar or working professionals who wish to participate in the Seminar are welcome to register and attend.

#### Abstract and Full paper Submissions

The abstract of the full academic paper for the paper Presentation and poster presentation sessions should reach us on or before 2nd September 2024. At least two subject experts will review the abstract, and the selected presenters will be notified by 7th September 2024. Registration fee should be paid on or before 30th September 2024, the registration fee once paid will not returned under any circumstances. # ABSTRACT AND FULL PAPER GUIDELINES

- 1. Abstract/Full Paper should have a cover page containing:
- · Full name and designation
- Institution/Organisation/University and professional/educational details
- · Email address and mobile number.
- 2. The submission should be in MS Word, i.e. doc/docx format, with the following specifications:
- · Font: Times New Roman
- · Line Spacing: 1.5 Points
- · Font Size:
  - Title: 16 Points
  - Sub-Title : 14 PointsBody Text :12 Points
  - · Points Footnotes: 10 Points
- 3. OSCOLA/Bluebook Citation method should be uniformly followed for footnotes. References and bibliography are not required.
- 4. Word Limit
- Abstract: 500 Words
- Keywords: 3-5 Keywords
- Full Paper: 3000 to 5000 Words
- 5. The submission should contain a disclaimer to the effect that the piece is original and has not been published or is under consideration, for publication, elsewhere.
- 6. All submissions are subject to a Plagiarism check.

A cash prize of ₹10,000 will be awarded to the best presenter and ₹5,000 to the second best presenter chosen based on evaluations by our esteemed panel of resource persons.
