Submission Guidelines

Abstract: Abstract shall not exceed 300 words and shall include five key words. The author(s) shall specify the title of the paper, Name(s) and designation of the Author(s). All abstracts should be submitted by filling the following Google Form Link <https://forms.gle/vMAB6Zu9ayTDBE7p9> on or before 19.08.2024. The Author(s) of shortlisted Abstract(s) shall be intimated on or before 24.08.2024.

Author and Co-Author: There may be an author and a co-author for a research paper

Registration: The authors of the selected abstracts have to register and pay the prescribed fee before the submission of full paper. **Author and co-author have to pay their fees individually for registration.** Co-authors will have to use the same registration form. Full Paper: The conference paper should be original, unpublished and should adhere to the conference theme. Full Paper can be submitted using the following Google form link <https://forms.gle/NiRmJb23TEkRsGcBA> on or before 09.09.2024

Word Limit: Full paper should not exceed 3000 words.

Text: Size 12-pt. Times New Roman, 1.5 Line Spacing; Heading 14-pt (bold), Times New Roman: Sub-headings 12-pt (bold), Times New Roman.

Reference Style: Authors to cite reference and avoid plagiarism. The Blue Book: A uniform system of citation - 21st edition reference style or APA reference style should be followed strictly.
