GUIDELINES

- The Editorial Board requires that all submissions adhere to the following guidelines:
- Use Garamond font, size 12, with line spacing of 1.5.
- Maintain margins of 1.5 inches on the left and 1 inch on the right, with 1 inch on the top and bottom.
- Citations should be hyperlinked within the document and the portion being referenced.
- The Board reserves the right to add additional links to sources relevant to the post.
- Submissions should be a minimum of 1000 words and must not exceed 1500 words
- Co-authorship is limited to a maximum of two authors.
- The manuscript should not contain the name of the author(s), institutional affiliation, or any other identification mark.
- The author(s) are responsible for the accuracy of facts, opinions, or views stated in the submitted manuscript.
- All manuscripts will be checked for plagiarism by the Editorial Board, and infringing, offensive, or plagiarized submissions will be rejected. A similarity index of 20% will be strictly adhered to all submissions.
