Submission Guidelines [Abstract]

- 1. Word Limit: 300-500 (inclusive of keyword, minimum 3)
- 2. Entire body must be in italics.
- 3. Font: Times New Roman, Size 12, Colour: Automatic/Black, Alignment: Justified
- 4. Portrait mode
- 5. Line spacing: 1.5
- 6.The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail ID, and Contact details of the Author(s).
- 7. The subject of the E-mail for submission of the Abstract must be "3rd International Virtual Conference: Abstract Submission".
- 8. There must be a single file containing the cover page and abstract.

- 1. Word Limit: 3000-6000 words (exclusive of footnotes).
- 2. Font: Times New Roman
- 3. Font size: 12 on an A4 size paper
- 4. Line Spacing: 1.5
- 5. Text alignment must be justified.
- 6. Footnotes should follow a uniform style of citation: Blue Book 20th Edition or OSCOLA 4th edn.
- 7. Font size 10 is to be maintained for Footnotes.
- 8. The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail ID, and Contact details of the Author(s).
- 9.The subject of the E-mail for submission of the Full Paper must be "3rd International Virtual Conference: Submission of Full Paper".
