INTERNATIONAL COMMERCIAL ARBITRATION

- All sessions of this course will be conducted in a LIVE format on the weekends.
- Each session will be 45 minutes – 1.5 hours long.
- An ASSESSMENT will be conducted after all the sessions are completed. The Top 3 scorers in the assessment would be RECOMMENDED for Internships. Please note that recommendations will only be at Indian organizations, which could also include organizations outside of the course panelists'.
- The FINAL DISCRETION on the allotment/purview/eligibility of internships lies with SimuLegum.
- All registered participants will receive a Certificate of Participation.
- Participants who complete the assessment will also receive a Certificate of Appreciation, with the percentage scored.
- The Assessment would consist of objective case study-based questions based entirely on the sessions.
