### CONCEPT NOTE

Human rights are a generic term as it embraces civil rights, civil liberties and social, economic and cultural rights. It can be said that these rights that all people have by virtue of being human are human rights. Rights being immunities denote that there is a guarantee that certain things cannot or ought not to be done to a person against his will. An individual can seek human rights only in an organized community i.e. a state where the civil social order exists. No one can imagine invoking them in a state of anarchy where there is hardly any right to a citizen. Area of Constitutional Governance & Human Rights are required to be focused and shall be discussed its challenges and with outcome through the International Conference.

Human rights are at the heart of the constitutional order of a modern State, not only determining relationships between the individual, groups and the State, but also permeating State structures, and decision-making and oversight processes. As a consequence, a bill of rights constitutes an integral part of a modern constitution. At the same time, gaps in the implementation of human rights at the national and international level, whether individual or where appropriate collective rights, often originate from shortcomings in the area of constitutional law.

As the highest law of a country, the constitution is at the centre of the political and social life of the country and defines the relationship between the State and the society, and between the different functions of the State. A country may have a constitution, but not necessarily "constitutionalism". Constitutional governance simply means 'governance' according to the constitution. It recognizes the need for the government insisting upon limitation being placed upon government powers. It envisages check and balances and put power of the legislature & executive under the restraints. Otherwise, it would jeopardize freedom of people and lead to an authoritarian oppressive government.

Furthermore, the Constitution acts as grundnorm which reflects the nature of the relationship between the institutions of government and the society and once the principles and duties join hands with rights; the State becomes a welfare state. Due to the welfare nature of the State, it

becomes the indispensable duty of the state to deal with its citizens to ensure proper functioning of the welfare machinery and do the oiling when required. The essence of good governance lies in respecting the human rights of individuals in order to strike a near perfect balance between development and empowerment. In that sense, human rights and individual development share a common vision and serve an overall purpose of development of all. Human rights are inherent in all the individuals irrespective of their caste, religion, sex and nationality. These rights are essential for the entire individual society as they are consonant with freedom and dignity and are conducive to physical, moral, social and spiritual welfare.

This conference seeks to lay an impact on the various challenges while implementing human rights in an effective manner keeping in mind.

# 2nd MMY National Moot Court Competition

## RULES AND REGULATIONS

### PART-I : TITLE, DATE AND VENUE

Sec. (1) The Maharishi Mahesh Yogi National Moot Court Competition 2024, shall be held on **3rd October –6th October 2024**

Venue: **Maharishi Law School**, MUIT, Noida, Uttar Pradesh.

### PART-II : LANGUAGE

Sec. (2) The competition shall be held only in the English Language.

### PART-III : ELIGIBILITY & TEAM-COMPOSITION

Sec. (3) The competition is applicable for those students who are pursuing a 5-year Integrated Law Programme OR LL.B (3-year course) OR Company secretary students from any college/institution/university within the territory of India.

Sec. (4) The team composition, for the competition, shall comprise of either TWO members (being designated as Speakers) OR THREE members (TWO of them shall be designated as Speakers and ONE Researcher).

Provided that a team may however consist of only TWO members in which case, no member shall be designated as Researcher.

Sec. (5) Any additional member, as mentioned under Sec. 4, will not be entitled to local hospitality. He shall also be not entitled to any kind of prize/ award in the competition.

Note (1):- No TEAM COACH shall accompany the participating team in the competition.

Note(2):- if any speaker OR researcher is found taking assistance of any kind of unfair means, the team shall stand disqualified from the competition at any stage.

Sec. (6) The Researcher may be permitted to argue as Speaker in case of illness OR any unforeseen event, the permission of the National Administrator in such case shall be mandatory.

Sec. (7) At any stage of competition Member-Swapping is strictly prohibited (that is any member of a team is requested by another team to plead on their behalf)

#### **PART-IV : ACCOMMODATION**

Sec. (8) Accommodation will be provided on first-come-first serve basis and the amount would be borne by participants and it will be non-refundable on cancelation.

#### **PART-V : REGISTRATION**

Sec. (9) The registration of the participating teams, for the Maharishi Mahesh Yogi National Moot Court Competition, 2024, shall be on a priority basis, that is, receiving the consent letters of the teams by way of Google form (Link:- <https://forms.gle/GPDAETDuSKX83aeDA> ) in the order of sending first. The preference of registering the teams shall be in the aforesaid manner only. However, the discretion of Dean, Maharishi Law School, shall be final. The participating teams are kindly requested to fill the registration form latest by 15th September 2024. The teams, who have filled their registration forms, shall be deemed to have been registered for the moot court competition. No alteration shall be made once the teams are registered, the intimation of which shall be confirmed by the moot court committee to the teams registered.

Sec. (10) The last date for sending the registered form shall be 15th September 2024

Sec. (11) The date for accepting registration forms shall not exceed the stipulated date as mentioned aforesaid.

#### **PART-VI : MODE OF PAYMENT**

Sec.(13) The registration fees for the MOOT COURT COMPETITION shall be Rs. 3500 (Three thousand and Five Hundred Rupees only) payable through,

## **PART-VII : DRESS CODE**

Sec.(13) The members of participating teams in the competition are mandatorily required to dressed up in their formal wear. Dress code shall be Western formals for Gentlemen and Western or Indian formals for Ladies. The teams should make their own provisions to comply with the dress code of the competition.

**Note:** *Any clarifications* regarding the moot court competition shall be adhered by the National Administrator in consultation with the moot court committee, the decision of which shall be final.

## **PART-VIII : STRUCTURE OF THE COMPETITION**

Sec.(13) The formal commencement of the competition shall commence from 3rd October, 2024 with the inauguration and shall conclude with the Valedictory function on 6th October, 2024.

The structure of the competition is classified as herein under mentioned:

1. **The Preliminary Rounds**
2. **The Quarter Final Rounds**
3. **The Semi Final Rounds**
4. **The Final Round**

Note: All rounds, as mentioned above, shall be on the basis of **Knock- Out**.

Sec. (15) **Preliminary Rounds**

Sec. (15) (1) The Preliminary rounds shall comprise of Two Rounds of oral arguments subject to the allotment of team codes. In the preliminary rounds, each team shall have to argue twice, once as a petitioner and the other as a respondent. The preliminary rounds shall take place on 4th October, 2024. The teams shall be escorted to their respective court rooms on the basis of their draw of lots. The draw of lots shall be done in presence of all the participating team by the Moot Court Committee.

Sec. (15) (2) Once the team code and *draw of lots* is been disclosed to the teams, it shall be the duty of the respective teams as not to disclose their identity.

On the same day i.e. 4th October 2024 the “**Researcher Test**” shall take place. Only the Researcher, as indicated in the team registration, shall take the researcher test, the speaker can only take the researcher test if the team comprises only two speakers.

**Note:** No two Teams will argue against each other more than once in the Preliminary Rounds.

Sec. (15) (3) The winners of the preliminary rounds shall, i.e. total eight teams (8 teams) shall qualify for the Quarter Final Rounds. The Quarter Final Rounds shall take place on 5th October, 2024 The Teams qualifying to the Quarter Finals shall be on the basis of Two Rounds of Oral arguments of the Preliminary Rounds.

Sec. 15 (4) The *Semi final* rounds shall comprise of Four teams. The Semi Final rounds shall take place on 5th October, 2024. The winner of the Quarter final rounds shall be declared qualified for the Semi Final Rounds.

Sec. 15 (5) The Final Rounds shall take place on 6th October, 2024. The two teams who stand declared as winners of the Semi Final Rounds shall qualify for the Final Rounds.

**Proviso:** In case of evaluation of All Rounds the Memorial Marks *shall not* be included to decide the merit.

**Proviso:** In case a **tie** takes place in the Quarter Final, Semi Final or Final Rounds, in that case, the marks of the Preliminary Rounds shall be the basis for deciding the winner.

However, in the Preliminary Rounds, in case the Round Total of the two teams is the same, the team with higher Memorial marks will be credited with a win.

Sec. 15 (6) Evaluation and Time Allocation for All Rounds

- i) **Preliminary Rounds: 20 minutes for each team**
- ii) **Quarter Final Rounds: 25 minutes for each team**
- iii) **Semi Final Rounds: 30 minutes for each team**
- iv) **Final Rounds: 50 minutes for each team**

## **PART- IX : TEAM CODING**

Sec.(16) The teams, participating in the competition, shall be allotted a TEAM CODE subsequent to the conformation of their registration process. It is to be noted, after the allocation of the team code, to the respective teams, shall be subject to strict confidentiality, the violation which may result in the disqualification of such team. The decision of the Moot Court Committee and National Administrator shall be final in this regard.

## PART-X : MEMORIAL RULES

Sec.(17) (1) All teams shall submit Memorials from both sides (Plaintiffs and Defendants) .

Sec.(17) (2) **Requirements of the Memorials**

All teams must submit typed Memorials for both the sides fulfilling the following specifications: The Memorial must contain the following parts:

(a.) Cover Page

(b.) Table of Contents.

(c.) Index of Authorities.

(d.) Statement of Jurisdiction.

(e.) Statement of Facts.

(f.) Issues Involved.

## MOOT PROBLEM

In the culturally diverse union of states known as Industan, marriage holds profound significance across all traditions, celebrated as a sacred union and festive occasion. Living-in relationship, perceived as a Western concept, are viewed with skepticism by many in Industan, who fear it may undermine the traditional family structure. Despite the recognition of such relationship by the Hon'ble Apex Court of Industan, societal attitudes persist with some still believing that cohabitation without formal marriage is inappropriate, especially for individuals as young as 18 years old. Instances of infidelity and the birth of children outside of wedlock have only reinforced the distrust surrounding living-in relationships.

Aman, a 22-years-old college student, and Anurag, his 23-years-old college mate, embarked on an entrepreneurial journey, establishing Shoeshine.com, a business specializing in shoe sales and repair. Their meeting with Sukirti, a 19-years-old college student, in the canteen sparked a romantic interest in Aman, who was captivated by her beauty, intelligence, and artistic talent in animation, video editing, and VFX. Likewise, Sukirti found herself drawn to Aman's charisma, ambitions and innovative ideas.

Their budding relationship took a significant turn when during a college break, Aman confessed his feelings for Sukirti during a trip to a hill station. Sukirti accepted the proposal on the condition that Aman will marry her after their college is over. Despite their emotional connection, Aman remained nonchalant about the relationship, while Sukirti invested herself fully to nurture it.

As their business venture progressed, Aman and Anurag recognized Sukirti's talents and Anurag proposed the idea of making her a partner in their business, offering her 20% share to which Aman agreed contingent on six months of dedicated work. Later on, Aman asked Sukirti about the same and she accepted the offer contributing her skills as a video editor and content developer.

Amidst their professional collaboration, Aman gifted Sukirti a mobile phone as a token of appreciation for her work and invited her to live with him in a rented apartment where they shared a life akin to husband and wife.

On November 25, 2022, during a conversation, Aman promised Sukirti a 20% share in their business after six months of dedicated effort. Sukirti received news that her mother was seriously ill, prompting her to work from home. Despite the circumstances, Sukirti committed herself wholeheartedly to her work with Aman assuring her via Instant Messaging that she would receive her share upon her return. While Sukirti's efforts yielded profits, they fell short of Aman's expectations, although Anurag acknowledged her contributions by gifting her an expensive handbag.

After the stipulated six months, Sukirti, while having breakfast with Aman, inquired about her promised share in the business. Aman's evasion of the question exacerbated tensions in their relationship. Days passed by with occasional arguments. Once, when Aman returned to their rented apartment, he saw Anurag holding Sukirti in his arms and taking her towards the bedroom. Aman confronted them and warned Anurag not to come to their apartment ever again. Sukirti told Aman that while making a cup of tea, she slipped in the kitchen and Anurag was only trying to help her. After a few days, things went back to normal.

As their contract approached its end, Sukirti asked Aman to get married to her as their college was ending as well. Aman expressed his intent to discuss the matter with his parents and assured Sukirti that they would move in together ten days prior to the end of their rental agreement.

However, 10 days passed by and there was no sign of communication from Aman's side. Sukirti took matters into her own hands, informing her parents about their relationship. Sukirti's parents intended to initiate discussions with Aman's family but before they could, Aman sent a message to Sukirti, terminating their relationship and accusing her of infidelity with Anurag. This turn of events further strained their relationship. When neighbours got the news about Sukirti's relationship, they accused her because she lived with him without marriage. Aggrieved by cheating, Sukirti filed a rape case against Aman as well as for breach of contract. Aman was sentenced for the charges of rape and breach of contract. The Session Court in its judgment held that, "Aman made a false promise of marriage and had sexual intercourse with her and even broke the contract between them about the transfer of 20% Shares of Shoeshine.com".

Aman appealed before the Hon'ble High Court of Gondwania and contended that "Sukirti broke the essence of marriage i.e., trust. She had affairs with his business partner Anurag. Once, he saw both of them in an intimate position. He contended that they had a contract of eight months and for that he paid and there is no formal contract about the transfer of 20% business shares." The Hon'ble High Court reversed the previous judgment and discharged him. This case brought too much media attention.

An appeal was filed by Sukirti before the Hon'ble Supreme Court. The NGO named 'Woman is the Future' was made a party to the case to present its view on the Live-in Relationship.

**The Supreme Court clubbed the cases and framed the following issues:**

1. Whether the appeal filed by Sukirti is maintainable in the court or not?
2. Whether Living-in-relationship is destroying the essence of marriage or not?
3. Whether Aman's promise to marry Sukirti constitutes a false promise amounting to rape under the prevailing laws of Industan?
4. Whether Sukirti's claim of breach of contract is valid given the nature of the agreement and the circumstances under which it was made?

**Note:** All the Statutes and Precedents of Industan are *pari materia* with those of India. All the issues are compulsory to deal with. Teams can frame extra issues or reframe the above issues.

4. The interview and post-consultation period is for 35 minutes only [25 minutes (Interview) +10 minutes (Post-Consultation)].

5. The finalists will be given an extra time of 10 minutes with the client in the final round.
6. During the consultation and post-consultation, the team may use books, notes, and other materials.

## **ROUNDS**

### **There shall be three rounds**

1. **Preliminary Round:** All teams shall compete against each other and the top 10 scoring teams shall be carried forward to the next round.
2. **Semi-final Round:** Top 10 teams from Preliminary Round shall compete against each other and the top 3 out of them shall be carried forward to the next round.
3. **Final Round:** Top 3 teams from Semi-Final Round shall compete against each other and the winner and the runners up shall be declared from them.

## **RULES FOR THE COMPETITION**
