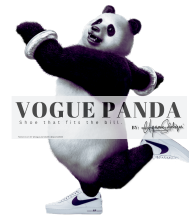

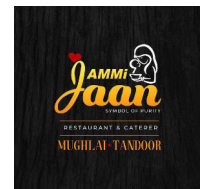

RULES & REGULATIONS

GENERAL RULES AND INFORMATION ABOUT XAVAEQUITAS

The inaugural edition of **XavAequitas'24**: St Xavier's National Moot Court competition shall be hosted and administered by the Moot Court Society, Xavier Law School, St. Xavier's University Kolkata.

Date of the Competition:

The competition shall be held on the **24th, 25th and 26th of October 2024**.

Venue of the Competition:

The competition shall be held within the premises of St Xavier's University, Kolkata based within the state of West Bengal, India.

Address: St Xavier's University, Kolkata. Action Area III B, New Town, Kolkata- 700160

Official Language of the Competition:

The language of the competition shall be **English**. All oral and written submissions are required to be made in English

Structure of the Competition:

The competition shall start and conclude within the 3 days as mentioned. The competition shall consist of four (4) rounds; **Preliminary Rounds, Quarter-Final Rounds, Semi- Final Rounds and the Final Round**.

The rounds shall take place as follows.:

24th October 2024 (Day 1)	Preliminary Rounds 1 and 2
25th October 2024 (Day 2)	Quarter Finals and Semi-Finals
26th October 2024 (Day 3)	Finals and Valedictory.

*Teams will alternate between sides in the Preliminary Rounds. No Team shall represent the same side in Prelim 2, which was represented by them previously in Prelim 1.

*Quarter-finals, Semi-finals and Final rounds will be knockout rounds.

Eligibility for Participation and Team Composition:

The competition is open to all students who are pursuing LLB three/five- year courses during the current academic year.

- Each team should consist of **three members**.
- There shall be two speakers, and one researcher designated for each team.
- All Team related issues and queries should be answered at the discretion of the organisers.
- Teams should not disclose the identity of their institution; such disclosure shall invite penalties including disqualification. The decision for the same shall be at the discretion of the organisers.
- No additional team member other than the above three shall be entertained.

RULES & REGULATIONS

- Each team shall be assigned the team code through due notification. Teams shall use only their Team code for identification purposes. Names of participants shall not appear on or within the written submissions.

Bar on Number of Teams: A maximum of 5 Teams may be sent from **one Institution**. Any more registering from the same institution shall not be accepted.

AWARDS

- I. The team with the maximum score in the final round will be declared as the "**Winning Team**" and the team with the second highest score in the final round will be declared as the "**Runners up Team**".
- II. The speaker with the maximum score in the Preliminary Rounds will be declared the "**Best Speaker**".
- III. The team with the maximum Memorial scores will be awarded "**The Best Memorial**".
- IV. The researcher scoring the highest marks in the Researcher Test will be awarded "**The Best Researcher**".

The following positions shall be awarded:

1. Winners [1st Place]
2. 1st Runners up [2nd place]
3. Best Speaker - Petitioner
4. Best Speaker - Respondent
5. Best Researcher
6. Best Memorial



All above positions shall be gratified with prizes worth over ₹1.8L in total.

- Kindly note that the Winner, 1st Runner up, and Best Memorial shall be **awarded to the team** as a whole on behalf of their respective Institutions.
- Individual participants will be awarded the best Speaker (Petitioner and Respondent) and best Researcher.

Certificate of participation shall be given to all the participating teams.

- The awards, certificates of merit, and certificates of participation shall be given during the valedictory ceremony to be conducted on Day 3, which is 26th October 2024.
- At Least 1 person from each team must be present at the valedictory ceremony to receive the certificates and awards.
- No certificate will be given to the team before or after the valedictory function.

RULES & REGULATIONS

1. Definitions

The name of the **Xavier's National Moot Court Competition** shall hereby be known as "XavAequitas'24".

These rules shall be called the "Xavier's National Moot Court Competition rules, 2024".

- a) "Host" shall mean and denote **St. Xavier's University, Kolkata**.
- b) "Petitioner" shall include Appellant, Plaintiff, Petitioner, Complainant, Prosecution, Informant, etc.
- c) "Respondent" shall include Defendant, Respondent, Defence, etc.
- d) "Bench" refers to the judges duly invited to adjudge the oral rounds, collectively. All decisions and marking by the "bench" are deemed final and binding.
- e) "Clarifications" means an explanation published by the Host University on the moot problem, at any point of time of the competition to a query posed by any participating team within the given deadline.
- f) "Compendium" means a compilation or collection of legal or other authorities that a participating team seeks to rely upon during the round of oral pleadings.
- g) "Competition" shall mean "**XavAequitas**: Xavier's National Moot Court Competition"
- h) "Moot Proposition" means the Proposition released by the Organizers and shall include any subsequent clarification(s) as and when issued by the Organizers.
- i) "Oral Score" means the scores given by the judge to a particular orator of the participating team pleading before it during the round of oral assessment.
- j) "Speaker" or "Orator" shall mean the same and shall denote one of the two designated speakers in a participating team.
- k) "Researcher" means a team member who will sit with the teams at the Oral Rounds but shall not be permitted to address the Court during the Oral Rounds. The Researcher may, however, be permitted to pass notes to the Speakers at the discretion of the Judges. The researcher shall be the only person allowed to take the Researchers Test.
- l) "Organizers" or "Organizing Committee" (abbreviated as OC) means the Xavier Law School, Moot Court Society.
- m) "Participating Team," means the team, which is eligible to participate in the competition after completion of the registration procedure.
- n) "Participating Institution" shall be presumed to be the parent institution of the participating teams.
- o) "Rules" means the St. Xavier's National Moot Court Competition Rules.
- p) "Team Code" means a unique code assigned by the Host University to the registered participating team.
- q) "Written Score" means the scores given by the organisers to a particular participating team on the written submissions submitted by them according to the rules of the Competition.
- r) "Written Submissions" means the memorandum of written submissions (memorials) submitted by any participating team according to the rules of the Competition.

RULES & REGULATIONS

2. DETAILED STRUCTURE OF ORAL ROUNDS:

Preliminary Rounds:

- Each team shall present their arguments from one side in this round, i.e., Petitioner's side or the Respondent's side, as determined by the Draw of Lots.
- The top eight teams based on their Total Preliminary Score in the Preliminary Round shall qualify for the Quarter-Final Rounds.
- The total Preliminary score does not include the memorial score.
- In case of a tie between the teams, the memorial scores of the respective teams in the tie shall be considered to break the tie.

Quarter-Final Rounds:

- The top eight teams from the Preliminary Round shall proceed to the quarter-finals.
- This will be a knockout round; hence, winners will be decided based on courtroom win.
- The sides of the teams will be determined by a draw of lots. The Draw of Lots will also decide which team you will be competing against (There will be no pre-decided fixtures).
- The memorial scores will not be considered and in case of a tie, there will be a rebuttal round, to break the tie.

Semi-Final Rounds:

- The top four teams from the Quarter Finals shall proceed to the semi-finals.
- This round again will be a knock-out round. The draw of Lots will determine the sides of the teams. The Draw of Lots will also decide which team you will be competing against (There will be no pre-decided fixtures).
- The highest-scoring team in each semi-final round will advance to the final round.
- The memorial scores will not be considered and in case of a tie, there will be a rebuttal round, to break the tie.

Final Round:

- The winner of each courtroom fixture i.e., two teams from the semi-final round shall proceed to this round.
- A Draw of Lots will determine the sides of the teams.
- The highest-scoring team in this round will be adjudged as the winner of the competition.
- The memorial scores will not be considered and in case of a tie, there will be a rebuttal round, to break the tie.

RULES & REGULATIONS

3. WRITTEN SUBMISSIONS (MEMORIAL)

Every team which has successfully registered for the competition, is required to prepare two memorials:

- Memorial on behalf of the Petitioner(s)
 - Memorial on behalf of the Respondent(s)
- a) All teams are required to send soft copies of their memorials via mail with the Subject “Memorials (Team Code) – Xavier’s National Moot Court Competition.
 - b) A penalty of one mark per hour on each memorial shall be imposed for any submission made after the deadline specified. Memorials submitted 12 hours beyond the specified deadline shall not be evaluated.
 - c) Binding of Written Submission: The teams shall bind their written submission with any binding they deem convenient between channel file or spiral, however, spiral binding is advised.
 - d) Teams are not permitted to raise issues in the Oral Rounds that have not been submitted in the Written Submissions
 - e) The memorials which are submitted shall be considered final. After completing the Competition, the Organizers reserve the right to use the memorials as they deem appropriate.
 - f) All guidelines about Memorial Submission must be followed.
 - g) Non-compliance with the Memorial Guidelines will result in Direct Disqualification.

Note: Any difference between the soft copy and the hard copy will lead to direct disqualification.

A general deduction of marks will be done for errors including but not limited to Wrong file name or incomplete file name, failure to submit memorial as one file, exceeding page limit, failure to include required information on the cover page, failure to use correct color coding, wrong footnotes etc.,

I. Memorial Format

All soft copies of the Memorial submitted to the respective email must be in **Word Document Format**.

i. Cover Page:

- The cover of the Petitioner Memorial must be blue coloured, while the cover of the Respondent Memorial must be red. The colour of the memorial pages must not make the text ineligible to be read. All other pages, except the cover pages of all memorials, can be in Black and White.
- Non-compliance will result in Negative Marking.

ii. Team Code:

- The team code (allotted) must be ascribed to the top right corner of the cover page. The side for which the written submission is prepared must succeed the code. The teams must use “P” for “Petitioner” and “R” for “Respondent”. [For example, Team code 100 would present petitioner memorial as “TC-100P” and respondent as “TC-100R”]
- Individual names should not be mentioned anywhere in the memorials or written documents. Terms like Speaker 1 and Speaker 2 must be used in place of the member names, as per appointment in the Registration Form.
- Non-compliance will result in Disqualification.

iii. Margin:

- The written submission must maintain an equal margin of 1 inch on all sides.
- Non-compliance will result in Negative Marking.

RULES & REGULATIONS

iv. Font, size and line spacing:

- The text font should be Times New Roman only, size 12, and must be in 1.5 line spacing.
- Non-compliance will result in Negative Marking.

v. Footnotes:

- The footnotes must be in Times New Roman only, size 10, and single space.
- BLUEBOOK (21st Edition) – The Harvard System for Citation of Legal Authorities should be followed in the written submission throughout. Incomprehensible footnotes will warrant negative marking.

vi. Header and Footer:

- The font used for the header/footer, if any, shall be Times New Roman only, size 10, 1.5 line spacing.
- Non-compliance will result in Negative Marking.

vii. Memorial Content:

The Memorials are required to contain the following sections:

viii. PLAGIARISM

- Participants must refrain from plagiarism of any kind. Any use of publicly available information must be accompanied by proper citations.
- Participants should keep the plagiarism limit of their written submissions within 15 percent. Failure to comply with this rule may result in disqualification or negative marking.

ix. CHANGES IN SOFT COPY

- An attempt at sending a different, shortened, or corrected version of your pleadings as a soft copy will result in disqualification from the selection process for the competition.

x. CONDONATION OF DELAY

- Delay in submission of memorials will not be condoned on grounds like connection failure, network issues, etc.
- However, the Organising Committee shall have final discretion in case of application for condonation of delay.

RULES & REGULATIONS

- Decisions could range from full condonation to reduction of marks as the organisers may deem fit.

xi. EXCHANGE OF MEMORIAL

- Memorials shall be exchanged based on the Draw of Lots that will take place before the commencement of each round.
- The side to be represented and the team clash, as determined by the draw of lots, shall be final; and no request for changing the same shall be entertained.

4. ORAL PLEADING ROUNDS

I. Preliminary Rounds

- The preliminary rounds shall consist of Preliminary Round-I (“Prelim-I”) and Preliminary Round-II (“Prelim-II”). No two teams shall face each other more than once in the Preliminary Rounds.
- In Preliminary Rounds, each team shall argue from one of the sides as allotted in the draw of lots. In preliminary round II, each team shall argue from the other side as they did in the first round. The opposing team will be decided through the draw of lots.
- The marks of each preliminary round shall be the cumulative total of the marks of oral submissions of both the speakers and the marks of the Memorial of the side in which they are appearing for the preliminary round.
- The winners of the preliminary rounds, i.e., the top eight teams shall qualify for the quarterfinals from which the top four teams shall qualify for the semi-finals, and then the top two teams will go to the Final Round.

Time Distribution

- The teams shall get 20 minutes each for their respective arguments, including the opening statement and prayer in the prelims round.
- The time mentioned above includes the time allotted to the Questioning by the Judges.
- Speakers are not supposed to speak other than in their allotted chances. If they speak out of turn, their team will be penalised and marked negatively.
- The speaker may ask for additional time from the judges, not exceeding more than 3 minutes, which shall be at the discretion of the judges.
- Rebuttal and Surrebuttal Time allocated to the teams will be 05 minutes total outside the allocated 20 minutes each. **(20+20+5= 45 minutes per round)**

II. Quarter-final Rounds

- The quarterfinal round would be a knockout round. In this round, each team shall argue from one of the sides as allotted in the draw of lots.
- The marks of the quarterfinal round shall be the cumulative total of the marks of oral submissions of both the speakers and the team scoring higher would be moving ahead to the semi-final round.

Time Distribution

- The teams shall get 25 minutes each for their respective arguments, including the opening statement, and prayer.
- The Speakers of any team, in any round, will, under no circumstance, shuffle positions, i.e., Speaker 1 will never become Speaker 2 and vice versa.

RULES & REGULATIONS

- The time mentioned above includes the time allotted to the Questioning by the Judges.
- Speakers are not supposed to speak other than in their allotted chances. If they speak out of turn, their team will be penalised and marked negatively.
- The speaker may ask for additional time from the judges, not exceeding more than 3 minutes, which shall be at the discretion of the judges.
- Rebuttal and Surrebuttal Time allocated to the teams will be 5 minutes total outside the allocated 25 minutes each. (**25+25+5= 55 minutes per round**)

III. Semi-final Rounds

- The Semi-final round would be a knockout round. In this round, each team shall argue from one of the sides as allotted in the draw of lots.
- The marks of the semi-final round shall be the cumulative total of the marks of oral submissions of both the speakers and the team scoring higher would be moving ahead to the Finals.

Time Distribution

- The teams shall get 30 minutes each for their respective arguments, including the opening statement, and prayer.
- The Speakers of any team, in any round, will, under no circumstance, shuffle positions, i.e., Speaker 1 will never become Speaker 2 and vice versa.
- The time mentioned above includes the time allotted to the Questioning by the Judges.
- Speakers are not supposed to speak other than in their allotted chances. If they speak out of turn, their team will be penalised and marked negatively.
- The speaker may ask for additional time from the judges, not exceeding more than 3 minutes, which shall be at the discretion of the judges.
- Rebuttal and Surrebuttal Time allocated to the teams will be 5 minutes total outside the allocated 30 minutes each. (**30+30+5= 65 minutes per round**)

IV. Final Round

- In the final round, each team shall argue from one of the sides as allotted in the draw of lots.

Time Distribution

- The teams shall get 40 minutes each for their respective arguments, including the opening statement and prayer.
- The Speakers of any team, in any round, will, under no circumstance, shuffle positions, i.e., Speaker 1 will never become Speaker 2 and vice versa.
- The time mentioned above includes the time allotted to the Questioning by the Judges.
- Speakers are not supposed to speak other than in their allotted chances. If they speak out of turn, their team will be penalised and marked negatively.
- The speaker may ask for additional time from the judges, not exceeding more than 3 minutes, which shall be at the discretion of the judges.
- Rebuttal and Surrebuttal Time allocated to the teams will be 6 minutes total outside the allocated 30 minutes each. (**40+40+6= 86 minutes per round**)

RULES & REGULATIONS

NOTE: During each of the above-mentioned rounds, the order in which the teams shall present their arguments is as follows:

<u>Serial No.</u>	<u>Speaker Order</u>
1.	a) Petitioner Speaker 1
2.	a) Petitioner Speaker 2
3.	a) Respondent Speaker 1
4.	a) Respondent Speaker 2
5.	a) Rebuttal by Petitioner Speaker
6.	a) Surrebuttal by Defendant Speaker

Important points to be remembered:

- The Best Speaker Award shall be determined based on the individual aggregate score of the Speaker taken only from the Preliminary Rounds
- The Researcher shall not be permitted to address the Court during the Oral Rounds. The Researcher may, however, be permitted to pass notes to the Speakers at the discretion of the Judges.
- The use of mobile phones or any other electronic gadgets during the oral rounds would be strictly prohibited.

II. Researcher's Test

- The researcher's test will be held for the assessment of researchers from each team to test the Researcher's knowledge of the case at hand and the quality of the Research done by them, who is required to appear for the same.
- The Researcher's Test shall be conducted on **Day 2** of the Competition and shall commence from **10:00 a.m. to 10:30 a.m.**
- The Test will be taken in **MCQ Format**.
- The researcher that obtains the highest marks in the test will be awarded the "Best Researcher" Prize at the end of the Competition

RULES & REGULATIONS

- e) The team which fails to send their researcher for the exam, will not be considered for the “Best Researcher Prize.”

III. Marking Scheme:

- a) +4 for every correct answer,
- b) -0.50 for every question not attempted or answered wrong.
- c) Total No. of Questions: 25
- d) Time allotted for the Test is 30 Minutes

6. COMPENDIUM

- All participating teams at their option can prepare a compendium as a supplement to their memorial submission. The compendium may contain all relevant provisions of law and important judgments cited if any.
- There can be no arguments/argumentative interpretation of facts/judgments in the compendium. Any such arguments will be disregarded and shall result in penalization.
- The compendium may be presented to the judges for further reference and clarity of argument presented by the speaker.
- The compendium should not contain the identity of any team or any institution.

7. MISCELLANEOUS

a) SCOUTING

- Scouting shall be deemed to have happened if the speakers, researcher, or any other person affiliated with a team is found:
- Witnessing, hearing, observing, etc. the oral submissions in a Round in which the respective team has no part.
- Teams shall not be allowed to observe the orals of another team unless they have been officially knocked out of the competition.
- Scouting by any team is strictly prohibited and shall result in immediate disqualification.
- Any person may submit a complaint regarding Scouting to the Organizers.

b) ANONYMITY

- All teams must maintain strict confidentiality of their personal and institutional identities in an official setting and must not divulge any such information within their written or oral submissions.
- Participants shall ensure that anonymity is not violated while passing on any material to the Judges.
- No mark, name, seal, symbol, or logo of the institution/ college/ university must be present.
- Participants must ensure that the same is rendered unrecognisable.

c) JURY OF APPEALS

- The Jury of Appeal is constituted to ensure transparency in the competition and accountability of the organisers, concerning any dispute in the competition on the spot.
- If a Team believes that the Rules of the Competition have been violated at any stage of the Competition, the Team shall, within half an hour after the completion of the round in which the alleged violation has occurred, register a complaint with the Jury of Appeal of the Competition

RULES & REGULATIONS

- All Disputes arising between Participating Teams, participants, Judges and participants, Staff and participants, Participants and Organising Committee should be duly notified to the relevant court authorities (Court officers) and/or other Committee members.
 - Such Disputes or complaints shall be adjudged by the Core Committee of the Moot Court Society only, which shall serve as the jury of appeals and its decisions and directions shall be final.
- d) Any Rule can be added, removed, varied, or modified only by the Core Committee of the Moot Court Society at any given time and its discretion and such Rule shall have the same effect and must be adhered to by all participants,
- e) **ETIQUETTE:**
- Participants are expected to behave in a dignified manner and not to cause any inconvenience to the Organisers, the Judges of the Competition, or any of the other participants.
 - All Participants must adhere to customary Moot Court etiquette and discipline.
 - All participants must maintain a strict professional attitude and composure throughout the competition and not indulge in any disrespectful action or expression.
 - Any participant shall tolerate no form of sexual harassment, any action that can be construed as sexual harassment shall warrant strict disciplinary action that may even include disqualification and intimation to the participant's parent Institution.
 - The Organisers reserve the right to take appropriate action for any unethical, unprofessional, or immoral conduct, which may include direct elimination from the competition.
 - **Dress Code of Competition:** The teams should adhere to the Dress Code of the competition:
 - **Female Participant(s):** Western Formals (in Black and White) - shirt, trousers, blazer, tie Or Indian Formals along with Blazer
 - **Male Participant(s):** Western Formals (in Black and White) - shirt, trousers, blazer, tie.
- On other occasions while on campus, participants may wear casuals or formals at their convenience, which should conform to the dress code rules of St. Xavier's University, Kolkata.*
- f) Interpretation of Any Rule or regulation is to be done by the Organizing Core Committee only. The Core Organising Committee will have exclusive authority to interpret the Rules in instances of interpretational conflict. Such interpretation will be performed according to appropriate procedure and be guided by interests of fairness and equity.
- g) The interpretation placed upon these Rules by the Organising Committee shall be conclusive and the decision of the same regarding the application of these Rules shall be final.
- h) All Participants must adhere to the St. Xavier's University general rules and regulations outside of this brochure at all times throughout the competition period. [Including hostel rules and regulations].
- i) **USE OF ID CARDS:**
- Each participant will be issued a Participant card at the time of registration. Entry into the University campus and Exit shall entail the production of such Participant cards. It shall be mandatory for all participants to wear the Participant card at all times inside the campus.
 - Furthermore, Every Participant must possess a valid ID card from the respective institution they represent, possess such Identification at all times and produce such Identification when called for or required.

RULES & REGULATIONS

j) FORCE MAJEURE CLAUSE:

- In case of any Unforeseeable Circumstances or emergency, if the situation arises the Competition must not be held or cannot be held due to any reason.
 - In case of any event, which includes but is not limited to, a declaration of war, a disease epidemic, imposition of lockdowns and curfews, any riots, a cyclonic storm, an earthquake, or any other natural disaster due to "Act of God", the date of the competition may be revised and/or the competition may be conducted in an online mode.
 - The Competition will be deemed to stand postponed until further Notice and such notifications will be communicated to participants duly.
- k) Any Internal Regulations, matters, Concerns, or functioning relating to the competition including Modes of marking, draw of lots decisions, and marks allocation of teams and participants are reserved for the Organising committee and will not be justified or divulged to any participant or team.
- l) All facilities shall be provided only to the registered members of a team and no additional members, parents, observers, coaches or faculty advisors shall be accommodated.
- m) Facilities such as photocopying, library usage, internet connectivity, etc. may be provided subject to the convenience of the Organizers and will be informed to the teams closer to the commencement of the Competition. Irrespective, participants are requested to make their arrangements for the same.
- n) Hosts shall not be responsible for any loss of belongings of the team during the competition.
- o) If any one member of a team is notified or informed of any detail or information concerning the Competition, it shall be deemed as if the said team as a whole has been duly notified or informed.
- p) No audio recording or videotaping of oral pleadings is permitted without the permission of the Organizers, the Bench before which the team is scheduled to present, and the opposing Team. The Organizers reserve all rights to audio recording and videotaping, or any other form of audio or visual reproduction of any oral round or part thereof.
- q) Team(s) shall not approach the Bench with any complaints, under any circumstances whatsoever.

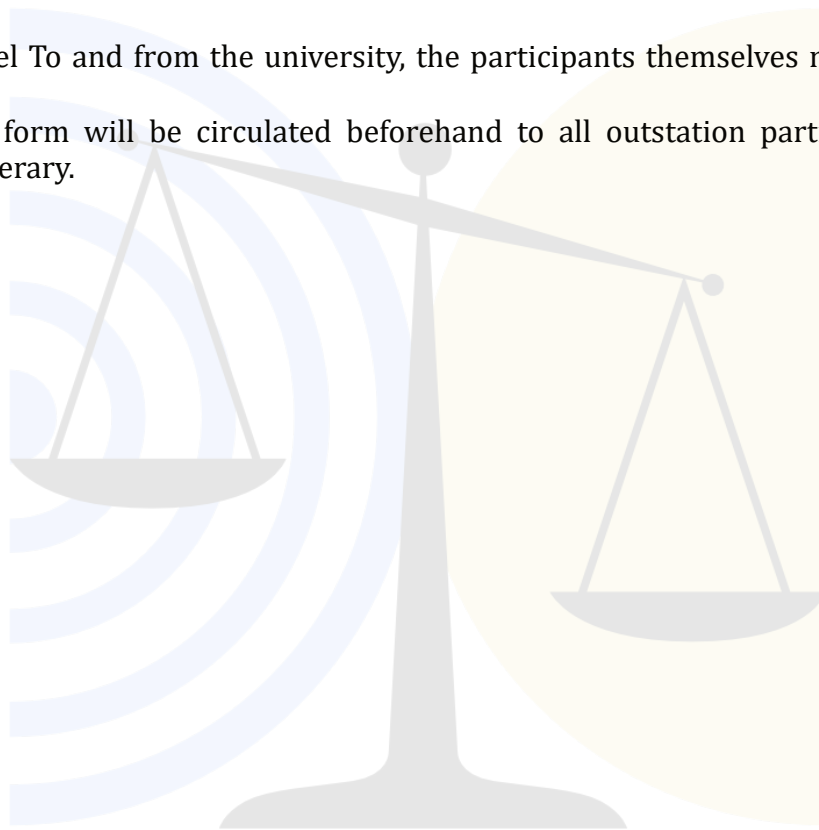
- Participants who do not avail of the accommodation services at the allotted time must arrange for themselves.
