Submission Guidelines for Papers

Language: Only English-language papers will be accepted.

Authors: Co-authorship is permitted up to two members.

Originality: The contributor should write the article/paper/chapter entirely. For plagiarism evaluation, the UGC plagiarism criteria shall be followed. Before submitting their manuscript, contributors are recommended to check for grammar and plagiarism before submission. The chapters should be submitted along with the plagiarism report either from Turnitin or URKUND only, and plagiarism should be less than 10 percent. No paper/chapter will be accepted without the plagiarism report.

Title page: The paper title, author(s) names, designation, affiliation, corresponding address, email ID, and mobile number should all be included in the abstract.

Abstract page: The word count must be between 250 and 500 words, including 4-5 keywords. The abstract must be placed next to the title page.

Full Manuscript Length: The manuscript should not be longer than 8,000 words, including the abstract and references.

Setup of the Manuscript Page:

• Page size: A4, portrait orientation, exclusively in MS Word format

- 1 inch from the top, bottom, left, and right of the page; 1 inch from the top, bottom, left, and right of the page; 1 inch from the bottom, left, and
- 12 point Times New Roman font
- 1.50 line spacing
- Page numbers should be inserted in the lower middle of each page.
- Capitalize the sub-heading. Each word is bolded and placed on its line.
- Figures and tables must be serially numbered, with the information source listed at the bottom left and linked to the text.

The referencing style should be in American Psychological Association format (APA).
