## Mode of Presentation

The word limit of the full paper shall be between 4000 to 6000 words (including footnotes / annexure / reports etc.) and must be accompanied with the following details:

A cover letter mentioning the Name of the Author(s), Course, Year of Study (if applicable), Name of the College/University (if applicable), Professional Position (if applicable), Title and Theme of the Paper, with Postal Address, Email Address and Contact Number.

The main text of the full paper and the abstract should be in Times New Roman with font size 12, heading font size 14 and line spacing of 1.5.

The footnotes should be in Times New Roman, font size 10 with spacing of 1.0 (Endnotes are not permitted)

One inch margins should be maintained on all four sides of the pages.

Citation Style: Bluebook, 20th edition.

All submissions must be made in the English language only.

The paper should be original and unpublished work of the author(s) and any form of plagiarism is strictly prohibited.

Plagiarism criteria: Maximum permissible limit will be 10 percent, excluding footnotes and bibliography.

The author(s) must give a declaration of the originality of the work. The UGC Anti-plagiarism guidelines shall be adhered. Author(s) shall solely be responsible for the accuracy of statements, opinion and view presented in the paper.

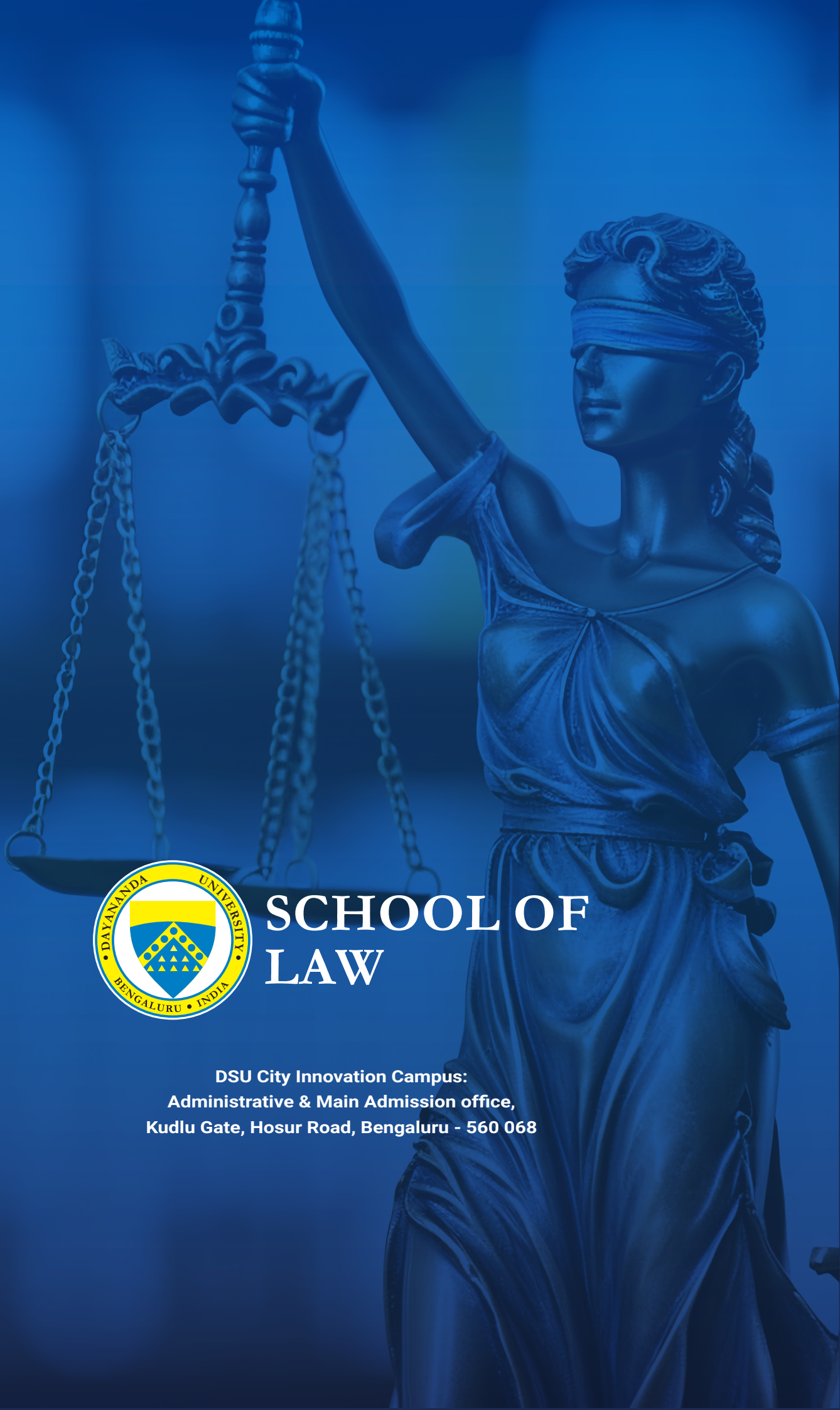
- › All participants will be provided certificate of participation
