ABOUT DR. D.Y. PATIL LAW COLLEGE, PIMPRI, PUNE







Essay Submission Guidelines

Authors must adhere to the following guidelines for their essay submissions

Essay Guidelines

- .The name of the author(s) or any other form of identification must not be mentioned in the essay.
- .Co-authorship is limited to a maximum of 1 author
- Word Limit: 1500-2000 words, excluding footnotes.

Font Style: Times New Roman.

- Font Size: 14 for headings, 12 for body text, 10 for footnotes.
- . Line Spacing: 1.5 for body text, 1.0 for footnotes.
- . Citation Style: ILI.
- Margins: 1 inch (i.e., 2.54 cm) on each side.
- Each individual or team is allowed only one submission.

Each entry must be previously unpublished work of the aurther(s). Articles that have been published elsewhere or selected/submitted for publication elsewhere will be disqualified.

Note: Speaking footnotes are allowed in the submissions but are not mandatory. If included, they should be limited to a maximum of 50 words each. The plagiarism limit is 10%, following UGC guidelines.

Use of artificial intelligence for submissions is strictly prohibited and highly discouraged.
