# Submission Guidelines

The Journal on Arbitration Law and Allied Fields (JALAF) invites submissions for its First Volume, First Issue, to be published in January 2025. Below are the guidelines to be followed for submission:

#### Themes and Sub-themes:

The Journal on Arbitration Law and Allied Fields encourages submissions that address a wide range of topics related to arbitration and its allied fields. While the following themes and sub-themes are provided as a guide, they are not exhaustive. Authors are encouraged to explore topics beyond these suggested themes:

#### i. Technological Advancements in Arbitration

- The impact of AI and machine learning on arbitration processes
- Blockchain technology and smart contracts in dispute resolution

#### ii. Cryptocurrency and Digital Assets

- Arbitration of disputes involving cryptocurrencies
- Legal challenges in digital asset arbitration

#### iii. Climate Change and Environmental Disputes

- Arbitration of climate change-related disputes
- Environmental impact assessments in arbitration

#### iv. Post-Pandemic Arbitration

- Handling COVID-19 related disputes
- Virtual hearings and their implications on arbitration

#### v. International Sanctions and Arbitration

- Impact of sanctions on arbitration proceedings
- Enforcement of arbitration awards under sanctions

#### vi. Cross-Border Disputes

- Jurisdictional challenges in international arbitration
- Enforcement of foreign arbitral awards

#### vii. Ethics and Professional Conduct

- Ethical considerations in arbitration
- Professional conduct of arbitrators

#### 2. Language and Format:

- Submissions are accepted only in the English language.
- The manuscript must be submitted in MS Word format.

#### 3. Co-authorship

- **Articles:** Co-authorship of up to 3 authors is permitted.
- **Short Notes:** Co-authorship of up to 2 authors is permitted.
- Book Reviews and Case Commentaries: Co-authorship is not allowed.

#### 4. Content Requirements

- **Originality:** The manuscript should be original, unpublished, and free from plagiarism.
- **Abstract:** Articles must contain an abstract of no more than 250 words.
- **Topicality:** The manuscript must relate to arbitration law or its allied fields.

#### 5. Word Limit

- Articles: 3000–5000 words (excluding footnotes).
- Short Notes: 2000-3000 words (excluding footnotes).
- Book Reviews: 1000-2000 words (excluding footnotes).
- Case Commentaries: 1000-3000 words (excluding footnotes).

## Note: The Editorial Board reserves the right to relax the word limit by up to 5%.

#### 6.Citation Style

 All citations must conform to the OSCOLA (4th Edition) citation style.

#### 7. Formatting

- **Title:** The manuscript title should be clear and relevant to the subject matter.
- Text:
  - Font: Times New Roman.
  - Font Size: 12.
  - Line Spacing: 1.5.
  - Alignment: Justified.
  - Margins: 1 inch on all sides.
- Footnotes:
  - Font: Times New Roman.
  - Font Size: 10.
  - Line Spacing: Single.

#### 8. Anonymity of Submission

- The manuscript must not contain the author's name, affiliation, or any identifying details.
- A separate cover page should be submitted with the author's name, affiliation, qualifications, and contact details, along with a brief biographical description

#### 9. Submission Instructions

- Submissions must be topical and align with the journal's scope.
- The submission should be **grammatically correct** and free from spelling or other errors.
- The **submission deadline** for manuscripts for the First Volume, First Issue of *JALAF* is **17th December**, **2024**. Submissions received after this date will not be considered for the January 2025 publication.
- All the submissions shall be made to the <u>google form</u>. Submissions through mails shall not be considered.

# **Editorial Policy**

- Authors, upon submission, must communicate their acceptance of the following conditions:
  - i. Upon publication, the work becomes the property of Damodaram Sanjivayya National Law University, Visakhapatnam.
  - ii.Permissions for subsequent publication, reprint, and/or derivative works must be obtained from JALAF.
- 2. JALAF follows a comprehensive peer review procedure. We strive to keep the authors informed about the current status of their manuscript as it moves through each stage of the review process.
- 3. The Editorial Board of *JALAF* reserves the right to refer certain manuscripts to the Board of Advisors for review, at its discretion.
- 4. The acceptable limits for plagiarism and AI-generated content are as follows:
  - i. Plagiarism: **10%**
  - ii. Al-generated content: 20%

#### Manuscripts exceeding these thresholds will be outrightly rejected.

5. JALAF retains **complete discretion** over the acceptance or rejection of manuscripts. The journal does not entertain requests for advance decisions based on abstracts, topic proposals, or outlines. Editorial decisions will be based solely on the review of the final manuscript submitted by the authors.

- After review by the Editors, manuscripts may be returned to authors with suggestions related to substance and/or style. Authors are expected to address these suggestions promptly.
- 7. JALAF reserves the right to request copies of any resources or authorities cited in the manuscript to ensure the accuracy and integrity of citations.

By submitting their manuscripts to *JALAF*, authors agree to abide by the above policies and cooperate with the Editorial Board to ensure a highquality publication.


