









ABOUT UNIVERSITY






ABOUT SCHOOL OF LEGAL STUDIES










ABOUT NATIONAL DRAFTING COMPETITION



THEMES



The participating teams are required to examine any real-life issue in relation to the given themes -

- Gender Equality and LGBTQ+ Rights
- Freedom of Speech and Expression
- Judicial Reforms

These themes are only suggestive, the participants are allowed to select a topic other than the above-mentioned. In that case, the topic can be related to any contemporary issue mentioned above.

ELIGIBILITY


- The competition shall be open for the students currently pursuing their Bachelor's Degree in law i.e. 3 year LL.B. course or 5 years LL.B. course from any recognized University/College in India.
- There is no restriction on the number of entries from any College or University.
- "Individual Participation" as well as "Participation in a team of two" is allowed

REGISTRATION PROCESS


•The participating teams should complete the Registration Form available at this link:

- Participation is free for all.

 - The deadline for registration is 20th NOVEMBER
 2024.








SUBMISSION GUIDELINES

- Each participating team must submit one PIL, Writ or both draft.
- If a participating team wishes to include any annexures to support their arguments in the draft (such as reports, commentaries, news clippings, pictures, etc.) they should compile all relevant annexures and submit it along with the draft.
- All the **PIL** draft or **Writ** petition or both must be sent to the email address: **Solsmootcourtcommittee@bbdu.ac.in** latest by **20th NOVEMBER 2024,** with the subject of the email as **"BBDU National PIL & WRIT Petition, Team Code** ___ "
- Submissions made after the deadline will not be considered for evaluation and will result in the disqualification of the participating team.
- Any submission with any name or reference of the participant will lead to disqualification. Submitting plagiarized content will lead to disqualification; participants must ensure their work is original.
- If the drafts of two or more participants or teams are found to be substantially similar, both teams will be disqualified.

COMPETITION FORMAT

- The submission of PIL and WRIT will be online.
- Results will be communicated through 'online medium' .
- The submission shall be in the English language only.
- The author(s) bear sole responsibility for the accuracy of facts, opinions, and views stated in the submission.






FORMATTING GUIDELINES

- •All drafts must be provided in PDF Format (.pdf) only.
- •The body of the submissions must be in the font "Times New Roman" with font size 12, having line spacing of 1.5 and justified. (The Font size for the Headings can be formatted as per the choice of the participants)
- The Footnotes shall be in Times New Roman, size 10, single line spacing, justified.
- The participants must follow a uniform citation (Bluebook 20th edition) throughout their submission.

CONTENTS OF THE PIL

- •The PIL is to be filed before the Supreme Court of India.
- The PIL draft must contain all of, and only, the following components:
 - Cover Page which should contain:
 - □The Unique team code in the upper right-hand corner.
 - □The name of the case;
 - Table of Contents
 - Table of Abbreviations
 - Index of Authorities
 - Statement of Jurisdiction
 - Facts of the Case
 - Issue(s) raised
 - Summary of Arguments/Pleadings
 - Arguments Advanced/Pleadings
 - Prayer
 - Table of annexures.
- There is no restriction on the number of pages.





CONTENTS OF THE WRIT PETITION


- Title and Introduction
 - The title of the petition, including the names of the petitioner and respondent.
- •A brief introduction stating the purpose of the petition.
- Facts of the Case
 - A detailed statement of the facts relevant to the case.
 - Background information and context.
- Questions of Law
 - Specific legal questions that the petitioner wants the court to address.
- Grounds for Relief
 - The legal grounds on which the petitioner is seeking relief.
 - Relevant laws, statutes, or constitutional provisions.
- Prayer for Relief
 - A clear statement of the specific relief or remedy sought from the court.
 - Any additional orders or directions requested.
- Annexures
 - Supporting documents and evidence are attached to the petition.

Note- The Writ petition is to be filed before the Supreme Court of India or any High Court.






