Theme: Essays must strictly adhere to the theme, “*Navigating IPR Challenges in the Era of AI and Metaverse*”.

Language: Submissions must be in English.

Word Limit: 3000–5000 words (excluding footnotes).

Formatting:

Font: Times New Roman

Size: 12.

Line Spacing: 1.5.

Footnotes: Times New Roman, Size 10, single spacing (20th Edition Bluebook citation style).

Originality: The essay must be original and not under consideration for publication elsewhere. Plagiarism beyond 10% will result in disqualification. AI-generated content will be subject to strict scrutiny and may lead to rejection.

Co-authorship: A maximum of two authors is permitted.

The essay must be submitted in .docx format.

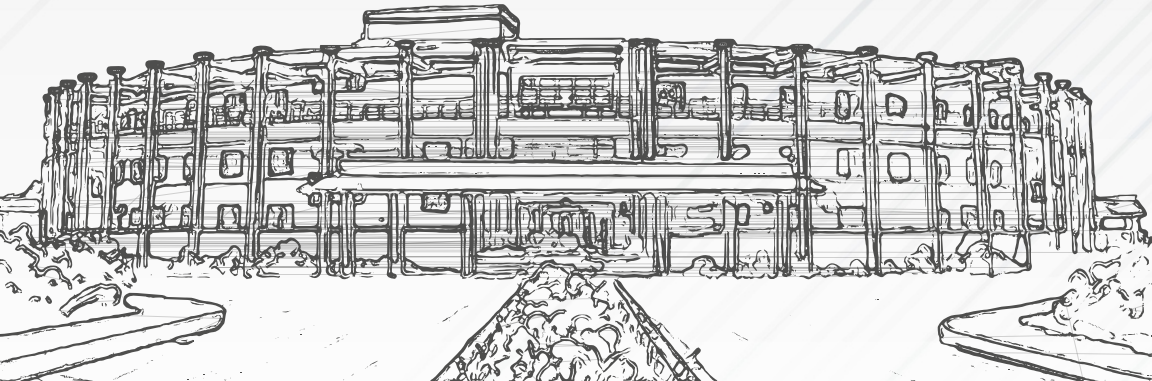
