ACCOMMODATION

Excellent accommodation facilities will be provided at JGU campus for our delegates, inclusive within the registration fees. There are clean and comfortable rooms equipped with double/ triple/ quad sharing accommodation with mattress, pillow, and duvet, and access to RO purified drinking water, and Wi-Fi. Gymnasium and sports facilities, health centre, food court, and convenience stores are also available within campus.

Alternatively, delegates may choose to stay outside the campus at nearby hotels with comfortable rooms at affordable prices. However, the organizing committee will not be responsible for booking accommodations outside campus. Shuttle services will be arranged to transport guests between hotels and the venue in the morning and evening.

HOW TO REACH THE VENUE?

Organizers will provide shuttle service between the Indira Gandhi International Airport and the venue on 19th and 22nd June 2025 for International Delegates. For airport transfers on June 20th and 21st, reliable cab services can be arranged for delegates on a chargeable basis, with prior notification to the organizers.

Delegates arriving from Delhi can use the JGU shuttle service from Haiderpur metro station (Yellow Line) to reach the conference venue. The metro network also connects to the airport, allowing delegates delayed due to unforeseen circumstances to reach Haiderpur Metro Station and then avail the JGU shuttle service.

From New Delhi Railway Station, delegates can take a taxi (1.5 to 2 hours depending on traffic) or the Yellow Line metro to reach Haiderpur. From Old Delhi Railway Station, a taxi to JGU takes approximately 1.5 to 2 hours, or delegates can use the Yellow Line metro from Chandani Chowk Station to reach Haiderpur. After reaching Haiderpur Metro Station one may avail the JGU shuttle service. Detailed shuttle schedules will be provided closer to the conference date.
