

Greetings,



### About the Article Writing Competition, 2025





The II JLUCCLHR Article Writing Competition, 2025. We are inviting articles over a wide ambit of subject(s) of Constitutional Law and Human Rights in Contemporary India.

The below-enlisted guidelines and rules shall govern the conduction and the proceedings of the II JLUCCLHR Article Writing Competition, 2025.

Notwithstanding anything mentioned in the guidelines and the rules, the Organizing Committee of the Competition (faculty & student members of the JLUCCLHR, hereinafter referred to as OC), shall reserve the right to vary, alter, modify or repeal any rule without any prior notification, if so and as they may deem necessary.

### 1. THEMES

- 1.1. The participants have the autonomy to choose any topic based on the subject area (s) of "Tracing Constitutionalism in the Era of Global Governance and Sequencing Human Rights Issues across Horizons" and subject matters incidental thereto.
- 1.2. The following theme(s) can be considered to research upon:
  - Comparing regional and global constitutionalism
  - Democratic Deficits in Global Governance Challenges of ensuring democratic freedom and democratic accountability (Across all the tiers (Local to International) of governance)
  - Rise of Nationalism and Populism vis-a-vis Human Right issues
  - · Constitutionalism, Development and Environment Protection
  - Impact of technological advancement on global governance and need for new constitutional frameworks
  - Constitutionalism, Law Enforcement Agencies and Issues of Human Right Violations
  - Constitutionalism and Digital Governance Issues of human right violations
  - Human Rights and Humanitarian Access in Conflict Zones: Displacement, Information Manipulation, and Global Obligations
  - Policy Responses to Racial, Ethnic and Gender Discrimination: Lessons from Global Perspectives
  - Labour Rights and Social Justice in the Age of Globalization
- 1.3. The themes are merely indicative, and the participants are free to choose any topic which resonates with the idea/concept of social justice and constitutional values.

### 2. ELIGIBILITY

Mode of the competition : Online

Language : English

**Eligibility** : Students currently enrolled in either five-year or three-year LL.B and Social

Science students of varied related major courses from any recognized University

or Law College are eligible for participation in the competition.



### 3. REGISTRATION GUIDELINES

3.1. Interested candidates are required to register themselves by providing the requisite details of the author(s) through the submission of the below provided Google form on or before **10th January**, **2025**. (Link to the registration form):

3.2. Registration Fees: 400/- INR

**Note:** The registration fee shall be non-refundable and non-transferable in any circumstance.

### 4. SUBMISSION RULES

All manuscripts should be the original work of the authors. The final decision for the selection of the article rests at the discretion of the JLU Centre for Constitutional Law & Human Rights (hereinafter JLUCCLHR or Organising Committee). The Manuscript is to be submitted through the provided Google form on or before 26th January, 2025. (Link to the submission form: https://forms.gle/YGtv7SpJZBKYuuej7)

The following are the guidelines to be adhered to while making submission of the manuscripts:

- 4.1. Word Limit: Minimum 800 1000 words (excluding footnotes).
- 4.2. Formatting Style: Font: Times New Roman; Size: 12; Line Spacing: 1.5; Alignment: Justified.
- 4.3. Formatting Style (Footnotes): Font: Times New Roman; Size: 10; Line Spacing: 1
- 4.4. Co-authorship is allowed up to two members.
- 4.5. Citations: Manu Citation/ Neutral Citation for case laws, and Uniform citation Harvard Bluebook 21st edn. for other references.
- 4.6. File Format: MS Word (.doc, docx) only.
- 4.7. File Name: "Name of the Author AWC". For Example, "RahulMishra AWC".

- 6.2. Selected Articles will be published by Manupatra after following the due process.
