### ELIGIBILITY

- Applicants must be full-time law or management faculty with less than 10 years of teaching and industry experience.
- No more than three participants will be selected from each country. Individuals or teams of two can submit proposals.

### SUBMISSION GUIDELINES

Research proposals should be in English and not exceed 1,000 words. Proposals should clearly outline the research question, methodology, theoretical framework, expected findings, and contribution to the field.

Submissions must be submitted by 30.01.2025.

### SELECTION PROCESS

A panel of renowned experts in law, business, and academia will evaluate proposals based on the following criteria:

- Originality and significance of the research question;
- ➤ Rigour of the proposed methodology;
- > Soundness of the theoretical framework;
- ➤ Potential contribution to the understanding of contemporary business and law issues.

### CONFERENCE CONTENT

- Selected participants will present their research ideas in online sessions.
- ➤ Interactive sessions will facilitate discussions and feedback from peers and experts.
- ➤ Workshops and keynote presentations by distinguished scholars will enhance knowledge and networking opportunities.
