We are delighted to announce that the next INSOL International Academic Colloquium will be held on **22-23 May 2025 in Barcelona, Spain**. The INSOL International Academic Colloquium will be preceded by the INSOL Early Research Academics (INSOL ERA) Annual Workshop held on 21 May 2025.

Additionally, the Academic Colloquium will feature an **invited panel** of leading scholars that will discuss some of the most recent trends and challenges at the intersection of insolvency law and new technologies. Confirmed speakers for this panel include:

The colloquium will focus on new trends and developments in insolvency law, as well as general challenges and perspectives on comparative and international insolvency law. We particularly welcome submissions analyzing any of the following topics:

- Arbitration, mediation and insolvency
- Valuation and financial issues in corporate reorganizations
- ESG and insolvency



- Insolvency law in emerging economies
- Corporate groups and insolvency
- Cross-border insolvency
- Distressed M&A
- Harmonization of insolvency laws, global trends and legal transplants

In any case, any topic potentially dealing with new trends and developments in insolvency law will be considered for presentation. We particularly welcome research papers that adopt comparative and empirical approaches, as well interdisciplinary studies on insolvency and restructuring that bring insights from different disciplines, including law, economics, finance, psychology, management and social sciences. We also encourage the submission of theoretical papers challenging existing approaches in insolvency law and providing new perspectives that can contribute to the improvement of insolvency law.

The Academic Colloquium will be open to full-time academics. Nonetheless, part-time researchers, as well as practitioners, regulators, judges and policymakers interested in participating in the Academic Colloquium can also submit their **expressions of interest** to present a paper. The expression of interest to present a paper or work-in-progress at the INSOL Academic Colloquium should be sent to Hatty Norman (<a href="https://harriet.norman@insol.org">harriet.norman@insol.org</a>), including the following information:

- Name, affiliation and contact details of the author/presenter
- Bio (no more than 150 words)
- Tentative title of the paper/presentation
- Abstract (no more than 300 words)

The expression of interest, along with the accompanying information mentioned above, should be submitted by **15 January 2025**. Papers accepted for presentation will be notified by **15 February 2025**. Early submissions are strongly encouraged.

The Academic Colloquium will offer many opportunities to connect with fellow academics in addition to the formal sessions. Presenters must register for the Academic Colloquium and attend in person.

**Early career scholars** are encouraged to submit proposals to the INSOL ERA Annual Workshop that will precede the Academic Colloquium.
