1. ABOUT THE DEPARTMENT OF LAW, CENTRAL UNIVERSITY OF KASHMIR

The Department of Law is a teaching and research centre at the School of Legal Studies, Central University of Kashmir. It was established in 2011 under the Coordinatorship of Prof. S.M.A. Qadri, a retired Professor from the Faculty of Law, University of Kashmir. Prof. Mehraj Uddin Mir, joined the department as a Professor in 2012, and became the first formal Head and Dean of the School of Legal Studies at the University. Later on, Prof. Mir became the Vice Chancellor of the Central University of Kashmir. Prof. (Dr) Farooq Ahmad Mir, former Head and Dean of the Faculty of Law and the Controller of Examinations at the University of Kashmir, and Registrar of Islamic University of Science and Technology (IUST), is the present Head and Dean of the School of Legal Studies. Prof Mir, a fellow of Max Planck Institute, Munich, Germany, has a significant research contribution to his credit which has been published in national and International Journals and enjoys a distinction of being presently associated with the Indian Law Institute, New Delhi for writing a part of Annual Survey of Indian Laws from more than a decade and a half. The Faculty members with distinctive academic backgrounds and specializations contribute to the widening and enrichment of the academic compass of the department. The department remains abuzz with the diverse academic activities that include seminars, webinars, workshops and moot court and other allied competitions. The department focuses on experiential learning of the students for which a Centre for Public Interest Lawyering has been established to horn the lawyering skill of the students. Presently, the department offers BA.LL.B.(Hons.), LLM with the specilaisations in Business law and Corporate Law and PhD programmes.

3. TIMELINE FOR SUBMISSION

The submissions for the journal are accepted on a rolling basis round the year. The interested authors can submit their manuscripts at any time.

4. SUBMISSION GUIDELINES

The journal welcomes contributions from academicians, practitioners, students of law and allied fields.

Before submitting a manuscript to the journal, the author(s) must ensure

- a) The manuscript is not submitted to any other journal for publication.
- b) The submission file is in Microsoft Word file format.
- c) Where-ever available, URLs for the references have been provided.
- d) The text is single-spaced with 12-point font in Times New Roman, and all illustrations, figures, and tables are placed within the text rather than at the end.
- e) The manuscript includes an Abstract of around 200 words followed by four to five keywords.
- f) Footnotes and Citations are provided as per the Indian Law Institute Rules of footnoting and Citation Style.
- g) The submission does not contain the name of the author or institutional affiliation or any other identification mark. A cover letter is attached separately with submission which contains name of the author (s), institutional affiliation, email id and phone number.
- h) The footnotes are in Times New Roman, Font Size 10 with Single Line Spacing.

- i) The submission contains a disclaimer to the effect that the piece is original and has not been published or is under consideration, for publication, elsewhere.

5. JOURNAL POLICY

- a) Manuscripts submitted for consideration in the journal shall be subject to the plagiarism check through Turnitin - one of the leading web-based similarity detection tools.
- b) No fee is charged from the authors for publishing their manuscripts in the Journal.
- c) The journal accepts manuscripts for possible publication around the year.
- d) The Editor of the Journal is disqualified from publishing his/her research work in CUKLR to ensure transparency and maintain the standard of the research papers by eliminating any kind of favour to him/her.
- e) Submissions are reviewed by one of the approved referees, not less than the rank of a Professor with expertise in the concerned area and not in any way connected with the Central University of Kashmir
