Additional Rules

Only one submission per participant is allowed. Essays must not contain any personal identifiers within the document to ensure fair evaluation. The organizing committee reserves the right to modify the guidelines. By submitting the essay, participants grant the organizers the right to publish or reproduce the essay with due acknowledgement. Prize money will be transferred directly to the winners' bank accounts, and the necessary details will be requested through a separate email.
