- Promote peace and mutual understanding through hands-on, practical scenarios.

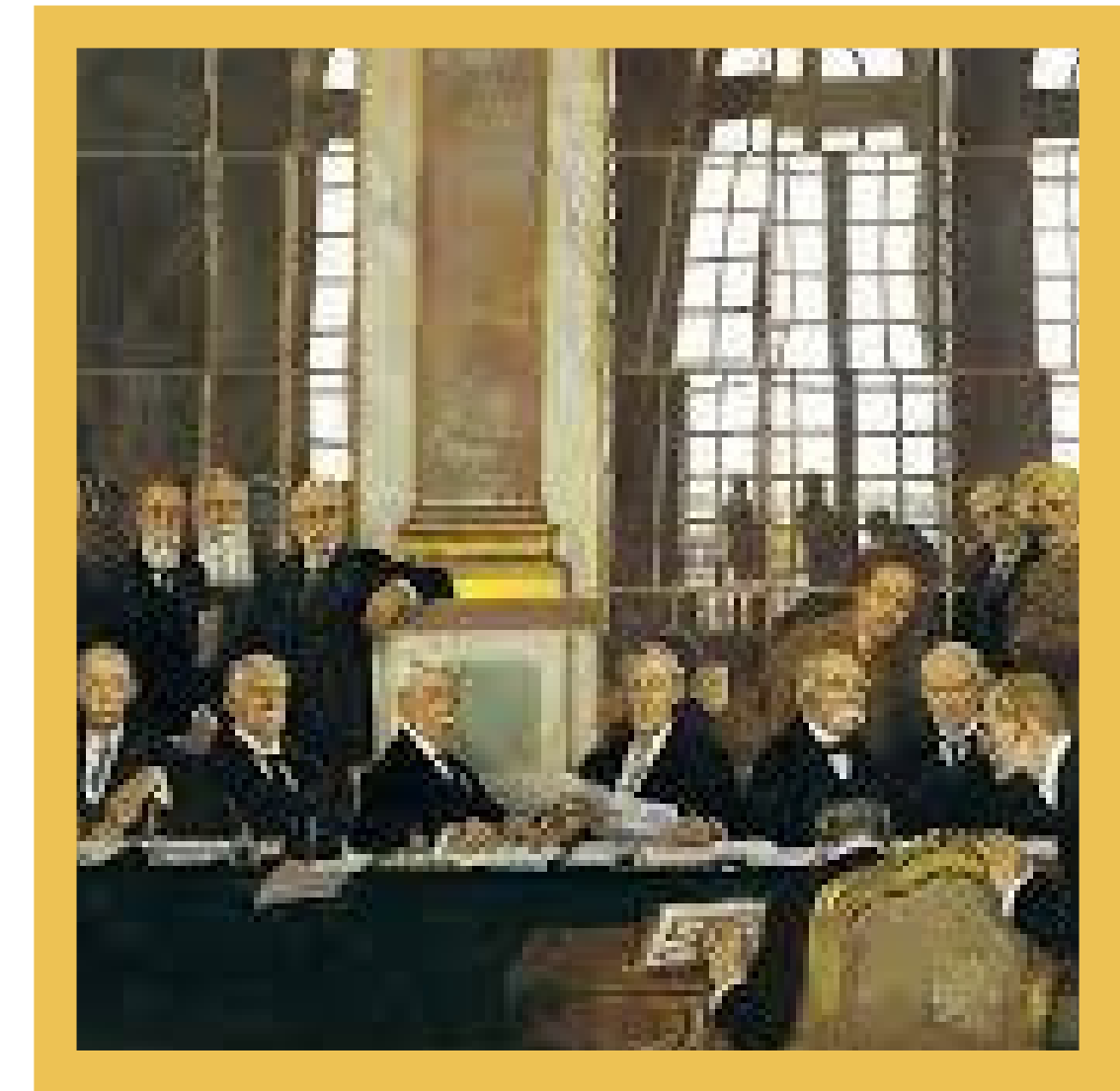
