PAPER SUBMISSION GUIDELINES

- 1. The Title of the paper should be followed by Name, Designation, Name of the Organization / University / Institution and Email address. It is mandatory to mention the Email address, as all future correspondence will be done through it.
- 2. Name and details of Co-author, if any.
- 3. **MANUSCRIPT:** The Manuscript should be in Times New Roman 12-point font. The Main Title should be in full capitals, bold, and centered 12-point font. Sub-titles should be in sentence case, bold, and in 12-point font. Authors' names should be in small capitals and centered in 12-point font.
- 4. **CITATION FORMAT:** Please use footnotes rather than endnotes. Footnotes should conform to Bluebook 20th Edition Style in Times New Roman 10-point font.
- 5.SUBMISSION OF THE ABSTRACT: A cover letter with the name(s) of the author(s) and address, designation, institution/affiliation, the title of the manuscript, and contact information (email, phone, etc.) is compulsory to submit. All submissions must contain an abstract of not more than 300 words with 5 Minimum Keywords;

6. ORIGINALITY OF THE MANUSCRIPT:

- All the contributions should be the original work of the contributors and should not have been submitted for consideration in any other Publication.
- *Plagiarism shall not exceed 10% excluding the Abstract. There should be no use of any AI model for content.*
- The paper must be in a single column laid out with margins justified on both sides.
- The length of the paper should be 3,000 5,000 words.
- 7. Submit your paper as a Microsoft Word (.docx) file to the given Email address with SUBJECT: "2nd AUMP Annual Conference Final Paper Submission" annualconference.alsaump@gmail.com.
