#### **Glimpse of Previous National Moot Court Competitions**

The First National Moot Court Competition at JIMS Engineering Management Technical Campus, Department of Law, was held in 2019 from February 15th to 17th, 2019,total with 36 teams participating from across the country. The moot problem was based on Constitutional and Civil Law. The participating teams were honored by the presence of distinguished judges, Hon'ble Justice D.D. Jha (former Judge of Allahabad High Court), Hon'ble Justice S.N. Dhingra (former Judge of Delhi High Court), Justice Zaki Ullah Khan (former Judge of Allahabad High Court), and Justice V.B. Gupta (former Judge of Delhi High Court).Dean of IP University- Prof. (Dr.) Kanwal D.P. Singh ,Secretary-Ministry of Law and Justice:G.N.Raju, DLC(Department of legal affairs-Ministry of Land Justice:K.C. Batlar .Demonstrating exceptional advocacy skills, the Ideal Institute of Management and Technology & School of Law, GGSIPU, emerged as the winners and lifted the trophy.

Continuing the legacy, the 2nd Edition of the Jagannath Memorial National Moot Court Competition was organized from February 14th to 16th, 2020 with participation of 20 teams nationwide. The event was graced by eminent legal luminaries, including Prof. M. Afzal Wani (Professor of Law and former Dean at the University School of Law and Legal Studies), Justice Zaki Ullah Khan (Retired Hon'ble Judge of Allahabad High Court, Lucknow Bench), Adv. Rajeev Saxena (Advocate, Delhi High Court), Justice V.B. Gupta (former Judge, Delhi High Court), Adv. Ranjan Roy (Advocate, Delhi High Court), Justice Swatanter Kumar (former Chairperson of the National Green Tribunal), Prof. Dr. S.K. Singh (Gautam Buddha University, Greater Noida), and Prof. S.K. Singh (Gautam Buddha University, Greater Noida). After intense competition, Rajiv Gandhi National University of Law, Punjab, emerged victorious.



#### **RULES & REGULATIONS**

#### **GENERAL**

Date: The 4<sup>th</sup> Jagannath Memorial Moot Court Competition shall be held offline from 28<sup>th</sup> February to 1<sup>st</sup> March 2025.

**Dress Code:** Participants are required to adhere to the following dress code at all times while being present in any Courtroom during the Competition.

- Ladies: Western Formals (White formal Shirt and Black Pant, Black Tie, Black Blazer).
- Gentlemen: Western Formals (White formal Shirt, Black Pant, Black Tie, Black Blazer).

#### THEME

Theme of the Competition is Criminal Law.

#### LANGUAGE

Communication for all official purposes for the online/offline Moot Court Competition is English.

#### **ELIGIBILITY**

The competition shall be open for *Bonafide* students who are pursuing a 5-year integrated LLB programme or 3-year LL.B programme from an Institute or University situated in India and recognised by the Bar Council of India.

#### **TEAM COMPOSITION**

- Each team shall strictly consist of three members. There shall be two speakers and one researcher in each team and the names of such speakers and researchers shall be informed at the time of registration. No additional member or observer shall be allowed to represent any team. Swapping of members is strictly prohibited.
- All participants shall bear with them at least one identity document for any probable verification during the mooting session(s).
- Each team shall be allotted a unique team code before the competition. During the competition, all teams shall be identified by the distinct team codes allotted to them.

• No Team shall disclose their identity or that of their institution or city etc. except to the organizers, when necessary, any such disclosure shall invite strict penalty including and not limited to disqualification, at the discretion of organizers.

#### **REGISTRATION**

Online registrations starts from 19<sup>th</sup> January 2025. The last date for registration is on 14<sup>th</sup> February 2025 at <u>https://forms.gle/KvZbD8BZ7jzj7Jkc7</u>.

- Registration fees ₹2100/-
- Registration shall be done on a first come first serve basis.

- The organising committee has the exclusive right to decide in case of any dispute. The decision of the organising committee in such a case shall be final.
- Screenshot of the Payment to be uploaded on form for confirmation of Registration.

#### **TECHNICAL RULES**

• Preliminary rounds shall be conducted via video conferencing (Virtual) and the advanced rounds shall be conducted via offline mode.

#### Platform of video conferencing will be intimated to the participants beforehand.

- All the participants of the team are expected to keep their videos on during the oral rounds.
- The link for the Inauguration, and the Preliminary rounds shall be sent to all the participants in advance.

- Participants have to ensure high speed internet connection with good audio and video facilities. It is advisable for the participants to use laptops or desktop for the oral rounds.
- In case any participant disconnects during the round, the Court Clerk after waiting for 10 (ten) minutes, will proceed further with the Oral Round.
- The participants should preferably have a plain background. The background or surroundings should not include any signage, color, logo, emblem, infrastructure, or any other display that reveals the identity of the participants or the institution they represent.
- Utmost care shall be taken by the teams as regards to external sound or noise while the proceedings are on. During the oral round, proceedings ensure that the same is conducted from a noise-free room.
- At the time when the other participant is speaking, you are expected to keep your mic mute. In case a participant is found disturbing the other pleader anyway, he/she may be disqualified.

#### **RULES REGARDING MOOT MEMORIALS:**

- All requirements have to be strictly followed. Non-adherence to the same shall result in disqualification, subject to the discretion of the organizers.
- Each team shall prepare Memorials for both sides to the dispute. i.e. Petitioner/ Appellant and Respondent.
- The soft copies of the Memorial from each side shall reach the Organizers at jimsnationalmootcourt@jagannath.org in pdf format latest by 21<sup>st</sup> February, 2025. Attachments shall be titled as [TEAM CODE] [P/A] for Petitioner/ Appellant side and [TEAM CODE] [R] for Respondent side. e.g. 007 P/A and 007 R.
- No extension shall be granted to any team for memorial submission in any case.
- Submission of Compendium is upon the discretion of the participants.

#### FORMAT OF MEMORIALS

- Cover Page: The cover page of the memorial must state the following:
  - Team Code on upper Right-hand side corner.
  - The Case Title
  - The colour of the cover page must be Blue in case of Petitioner / Appellant and Red in case of Respondent.
  - The Party for which the Memorial has been prepared.
    - Table of Content
    - List of Abbreviations
    - > The Index of Authorities
    - The Statement of Jurisdiction
    - The Statement of Facts
    - > The Statement of Issues
    - > The Summary of Arguments
    - > The Arguments Advanced
    - > The Prayer

#### MEMORIAL GENERAL FORMAT

- Spacing: 1.5 Line Spacing
- Margins: One-inch margin on all sides of each page.
- Font: The font for the body of the memorial shall be Times New Roman, Size 12.
- The Font for the footnotes: The font of the footnotes shall be Times New Roman, Size 10.
- Page numbering should be at the bottom middle of each page.

- The memorials must not contain any annexures/photographs/sketches / exhibits / affidavits etc.
- Teams shall cite authorities in their Memorials by way of ILI Style of Citation or any other uniformed style of citation.
- The maximum number of pages in each Memorial shall not exceed 35 pages including 20 maximum pages for Written Submissions/Arguments.
- The memorials must not, under any circumstances, reveal any information that could identify the participating team, its members, or the institution/college/university they represent which may lead to disqualification.

**EVALUATION OF MEMORIALS:-** Every Memorial will be marked on a total of 100 marks and the team's memorial marks will be the average of the total of both sides.

#### **RESEARCHER'S TEST**

- The Researcher's Test shall be conducted on <u>24<sup>th</sup> February</u>, <u>2025</u> through <u>online</u> <u>medium</u>.
- The Researcher's Test will consist of both Oral questions and subjective questions, focusing on the applicable laws, precedents, and facts related to the Moot Proposition.
- Only the participant registered as researcher from each team shall be allowed to appear for the Researcher's test.
- The participant shall ensure complete integrity and shall not resort to unfair means while attempting the test. Any such attempt shall result in disqualification.
- The Researcher's Test will be conducted online in a one-on-one format via video conferencing. Each researcher will have 15 seconds to orally answer each question. If a researcher fails to answer within the given time frame, the next question will be posed. The test will consist of 15 oral questions, each carrying one mark. Any detection of unfair practices will result in the disqualification of the team..

#### **ORAL PLEADING**

#### > PRELIMINARY ROUND

- The Preliminary Round of the Competition will be conducted via online video conferencing and shall consist of Forty (40) minutes of Oral Pleadings. Both the sides shall be allotted twenty (20) minutes each. The teams shall indicate their allocation of 20 minutes before the beginning of the round and no Speaker shall plead for more than twelve (12) minutes, including rebuttal or Sur-Rebuttal.
- Before the beginning of the Preliminary Round, each Team shall indicate to the Court Clerk how it wishes to allocate its 20 minutes among
  - o its first Speaker,
  - o its second Speaker, and

- Rebuttal (by Petitioner/ Appellant) or Sur-Rebuttal (by Respondent). At the discretion of Judges.
- There will be one preliminary round of arguments per team.
- Preliminary will be held on <u>24<sup>th</sup> February, 2025</u>, the top eight teams from Preliminary Rounds will qualify for the Quarterfinals.
- The criteria for succeeding in these rounds will be based on aggregate marks of the team gained in the Rounds.

#### > <u>QUATER-FINAL ROUND</u>

- Quarter-finals will be held on <u>28<sup>th</sup> February, 2025</u>.
- Quater-Final rounds shall consist of Fifty (50) Minutes of oral pleadings. Both sides shall be allotted Twenty-Five (25) minutes each. Further, the time for Rebuttal and sur-rebuttal will be 5 minutes. (Total time of each team will be 25+5 minutes). The teams shall indicate their allocation of 25 minutes before the beginning of the round and no Speaker shall plead for more than fifteen (15) minutes, excluding rebuttal or Sur-Rebuttal.
- The Quarter-final will be on a knockout basis, four teams from Quarter-finals Rounds will qualify for the Semi-Finals.

#### > <u>SEMI-FINAL ROUND</u>

- The Semi-Final Rounds will be held on <u>28<sup>th</sup> February</u>, <u>2025</u> and will be knockout rounds. The pairing of Teams for the Semi-Final Rounds shall be done by a draw of lots.
- Semi-Final rounds shall consist of Sixty (60) Minutes of oral pleadings. Both sides shall be allotted Thirty (30) minutes each. Further, the time for Rebuttal and sur-rebuttal will be 5 minutes. (Total time of each team will be 30+5 minutes). No Sur-Sur Rebuttal is allowed.

- The teams shall indicate their allocation of 30 minutes before the beginning of the Semifinal round. No speaker shall plead for more than 18 minutes during Semi-Final Round excluding Rebuttal or Sur-Rebuttal.
- Semi Final rounds will be on a knockout basis, two teams from Semi-finals Rounds will qualify for the Finals.

#### FINAL ROUND

- The Final Rounds will be held on <u>1st March, 2025</u>.
- The final round shall consist of Ninety (90) Minutes of oral pleadings. Both the sides shall be allotted forty-five (45) minutes each. Further, the time for Rebuttal and surrebuttal will be 7 minutes. (Total time of each team will be 45+7 minutes).
- The teams shall indicate their allocation of 45 minutes before the beginning of the final round. No speaker shall plead for more than 25 minutes during the Final Round excluding Rebuttal or Sur-Rebuttal.
- Extension of Time at Judges' Discretion- Judges may, at their discretion, extend total team oral arguments time maximum by 5 minutes.

#### **GENERAL RULES FOR ORAL ROUNDS:**

 Order of Submission- The order of the oral submissions in each Round at all levels of the Competition shall be: Counsel (Petitioner/ Appellant) 1 --> Counsel (Petitioner / Appellant) 2 ->

Counsel (Respondent) 1 --> Counsel (Respondent) 2 ->

Rebuttal - Counsel (Petitioner/Appellant 1 or 2) -->

Sur-rebuttal - Counsel (Respondent 1 or 2).

• Ex Parte Procedure: In exceptional circumstances, such as when a team fails to connect for a scheduled oral round, the Court Clerk may allow the oral round to proceed ex parte after waiting for ten (10) minutes. During an ex parte proceeding, the attending team will present its oral pleading, which will be scored by the judges to the extent possible, as if the absent team had been present and arguing. In such cases, the team that fails to connect for the scheduled round will forfeit all points for the oral round and be disqualified from the competition.

- In case of an odd number of teams or Ex-Parte at the competition, the organizers shall have the discretion of having one team from the organising institute for the purpose of even teams / ex-partes in the preliminary rounds and that team shall not be considered as a part of the competition.
- If a team from the organizing institute scores higher marks than the competing teams, the next highest-scoring team will still be given preference.

#### **SCOUTING**

- Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the team members shall result in disqualification.
- Any team can file a written complaint to the Organizers for the same. The Organizer's decision regarding scouting shall be final.

#### **ANNOUNCEMENT OF RESULTS**

- The results of the Preliminary Rounds will be announced after the completion of the rounds.
- The results of the Quarter-Final Rounds will be announced following the round.
- The results of the Semi-Final Rounds will be announced after the conclusion of the round.
- The winners of the competition will be announced during the valedictory ceremony.

#### **INTERPRETATION OF RULES AND REGULATIONS**

- All interpretation, as well as any waiver, consent or other decisions in the administration of the competition are at the complete discretion of the Organizers.
- Any decision made by the Organizers shall be final and binding on all the participating teams.

#### **COPYRIGHT**

- The copyright with regard to the memorials submitted for the participation in the Competition is assigned by participants and shall vest completely and fully on the Organizers. The participants shall certify the originality of the memorials and the materials used and shall be responsible for any claim or dispute arising out of further use and exhibition of these materials.
- The organizers reserve the right to publicly display, electronically or otherwise, and distribute this information in any manner they choose. They shall not be held liable for any loss caused by errors or omissions in this collection of information, nor for the accuracy, completeness, or adequacy of the materials provided.

#### **MOOT PROPOSITION**

#### The State vs. TechCorp

- I. TechCorp, a prominent technology firm in Indistaan, is under investigation by the Enforcement Directorate for alleged involvement in a sophisticated money laundering scheme that spans multiple jurisdictions and utilizes advanced financial technologies. The investigation stems from reports of significant financial irregularities linked to TechCorp's operations, including the use of shell companies and cryptocurrency transactions.
- II. TechCorp is a leading technology firm in Indistaan, specializing in software development and digital solutions. The company has a significant presence in both domestic and international markets, with reported revenues exceeding Rs. 500 Crore annually.
- III. The ED initiated an investigation following intelligence reports indicating that TechCorp was involved in a money laundering scheme using shell companies to obscure the origins of illicit funds. The investigation revealed that TechCorp allegedly created multiple shell entities to issue fake invoices for non-existent services, facilitating the transfer of funds across borders.
- IV. An internal whistleblower provided documents suggesting that TechCorp had funnelled approximately Rs. 200 Crore through these shell companies into offshore accounts, primarily in jurisdictions known for banking secrecy.
- V. The ED discovered that TechCorp utilized cryptocurrency transactions to further complicate the money trail. Reports indicated that over Rs. 50 Crore was transferred via cryptocurrencies like Bitcoin, which were then converted into fiat currency in various foreign banks. This aspect raises critical questions about regulatory frameworks governing digital currencies and their potential misuse for money laundering. The investigation highlighted that TechCorp engaged in remitting funds outside Indistaan using cryptocurrencies, which were disguised as payments for non-existent software imports from Singapore. This aspect raises questions about regulatory oversight concerning digital currencies and their role in facilitating money laundering.
- VI. The ED identified that these transactions were linked to a global forex settlement platform, NIUM Singapore Pte Ltd., which allegedly processed payments based on fake invoices raised by shell companies associated with TechCorp.
- VII. The ED conducted multiple search operations at TechCorp's headquarters and associated offices, seizing documents, digital devices, and financial records. Assets worth

approximately **Rs. 150 Crore**, including luxury cars and real estate holdings, were provisionally attached under the Prevention of Money Laundering Act (PMLA). During these operations, the ED also froze bank accounts linked to the shell companies, which contained substantial sums believed to be proceeds of crime. The ED's actions led to significant public scrutiny regarding its methods and the implications for corporate governance within tech industries.

- VIII. TechCorp is accused of generating **Proceeds of Crime (PoC)** through fraudulent transactions involving fake invoices and shell companies. These companies allegedly facilitated the laundering of funds through complex networks that obscure the true source and destination of the money.
  - IX. TechCorp's legal team argues that the ED's actions infringe upon their constitutional rights, particularly regarding due process under Articles 21 and 22 of the Indian Constitution. They contend that the ED has not provided adequate evidence linking them directly to any scheduled offense as required under the Prevention of Money Laundering Act (PMLA).
  - X. The defense also raises concerns about the lack of transparency in how the ED conducts its investigations, particularly regarding access to critical documents like Enforcement Case Information Reports (ECIRs).
  - XI. Following the investigations, the ED filed a charge sheet against TechCorp's CEO and several executives under PMLA provisions, alleging conspiracy to commit money laundering. The ED's actions have been met with legal challenges from TechCorp, which argues that the agency has failed to establish a clear link between its activities and any scheduled offense as defined under PMLA.

**Note:** All the laws of Indistaan are pari-materia to that of India and this proposition is a work of fiction. Any events or names mentioned if coinciding with real-life events is pure coincidence.

#### The participants are required to present arguments on the following issues:

 Whether it is necessary for the ED (Enforcement Directorate) to establish a clear connection between alleged money laundering activities and a recognized scheduled offense before initiating proceedings under the Prevention of Money Laundering Act (PMLA)?

- 2. Whether constitutional protections apply in cases involving economic offenses? Specifically, what are the implications of denying access to Enforcement Case Information Reports (ECIRs) on due process rights under the Constitution?
- 3. Whether corporate entities like TechCorp can be held liable for financial misconduct perpetrated by their employees? What standards should be applied when determining the culpability of corporate bodies in such instances?
- 4. Whether, given the increasing use of cryptocurrencies in alleged financial crimes, regulatory measures should be implemented to prevent misuse while balancing the need to promote innovation and technological development?
- 5. Whether recent judicial interpretations affect the operational scope of investigative agencies like the ED? What implications do these rulings have for future investigations into corporate entities and economic offenses?
- 6. Whether the provisions of the BNSS affect the procedural aspects of the ED's investigation? Are there specific statutory requirements that must be fulfilled before the agency proceeds with arrests or searches under this framework?
- 7. Whether the definitions and penalties outlined in the BNSS apply to TechCorp's alleged actions? Can the company and its employees be effectively prosecuted under this new legal framework?
