MOOT RULES

- General Rules: "Organizers" means the Moot Court Committee, Sharda School of Law, Sharda University
- 2. "Competition" means the 9th Anand Swaroop Gupta Memorial International Moot Court Competition, 2025
- 3. "Participating Team means the team which has registered itself for the competition as per the rules given below. 'Participating College/Institution/University' shall be presumed to be the parent institution of the participating team
- 4. "Participants" means the speakers and the researcher of the Participating
- 5. The rules of the Moot Court shall be strictly adhered to. Any deviation from them would attract disqualification or other penalties as decided by the Organizers. Decision taken bythe Organizers in case of any doubt, dispute, disqualification etc shall be final.
- 6. Registration will be on first come first serve basis.
- 7. Date and Venue of the Competition: The 9th Anand Swaroop Gupta Memorial International Moot Court Competition, 2025 shall be held from 3rd-5th April, 2025.

Venue: Sharda School of Law, Sharda University. International Teams can participate in Online Mode

- 8. Eligibility: The Competition is open to bonafide undergraduate students of recognized Colleges/Institutions/Universities who are currently pursuing their Bachelors Degree in Law ie 3 year LLB or 5 year Integrated or Honors' LL.B Programme with all combinations on a regular basis.
- 9. Team Composition: Each team shall comprise of a maximum of 6 members and a minimum of 2 members consisting of either 2 speakers and 1 researcher or 2 speakers only the number cannot be modified under any circumstances. Teapis shall identify the speakers and researcher at the time of Registration. No extra member/faculty/observer shall be allowed. Also, no deviation from the chosen names shall be allowed. Not more than Two Team from the same Institution shall be allowed to participate in the competition.

7. Deduction of marks for late submission of soft copy of the Memorial:

Late submission, if any, of soft copies of the memorials may be permitted by the Organizing Committee in exceptional circumstances on a case to case basis upon prior request of the participants subject to a deduction of 2 marks per for late submission of the hard copies and subject to a maximum limit of 2 days after which it won't be accepted

Note:- Participants are requested to strictly adhere to the rules concerning time limit for submission of the memorial

8. Exchange of Memorials:

The exchange of the memorials will be done according to the team codes allocated by the Moot Court Committee

9. Language:

The official working language of the 8th Anand Swaroop Gupta Memorial I international Moot Court Competition 2025 shall be English.

10. Dress code:

- Inside the Court Room, participants shall be in formal wear only. However, robes or collar bands are not allowed.
- -Female participants are required to wear either a full suit comprising of a black formal blazer and trousers, full sleeved white shirts or white kurta, black bottom wear, black blazer/overcoat
- Male participants are required to wear a full suit comprising of a black formal blazer and with formal foot wear. trousers, full-sleeved white shirts, black tie, and formal footwear

11. Identification of Participating Team:

Each team will have a team code and each participant shall be given an Individual code.

Disclosure of identity of the parent/college/institution/university shall be made only in the registration form. Disclosure at any other point of time during the competition shall be liable for penalty which includes disqualification.

12. Anonymity:

Participants shall not disclose their names and the identity of their respective college/institution/organization at any time before the award of the ceremony. The individual code and the team code shall be the sole source of identity of the respective teams throughout the competition. Any disclosure against this rule shall invite penalty including disqualification

13. Inauguration and Draw of Lots:

The formal inauguration and draw of lots of the 9th Anand Swaroop Gupta Memorial International Moot Court Competition. 2025 shall be held on 3rd, 4th & 5th April, 2025.

14. Structure Of The Competition:

- -Preliminary Round
- Quarter Round
- -Semi-Final Round

-Final

Preliminary Round: In the Preliminary Round, the teams shall be allowed to argue from both sides. In this round, the teams shall be chosen based on their score. Each team shall be given only 20 minutes to present their case. Based on the score, eight teams shall be selected for the Quarter Round.

Quarter Round: In the Quarter Round, the teams shall be allowed to argue from both sides. In this round, the teams shall be chosen based on their score. Each team shall be given only 20 minutes to present their case. Based on the score, four teams shall be selected for Semi-Final Round

Semi-Final: In the Semis the decision shall be based on knockout. Accordingly, two teams shall reach the Final Round. Each team shall be given 30 minutes to argue their part including rebuttals

Final: Each team shall be allotted 30 minutes to present their case including the rebuttals.

Important Note:

All four stages of the competition shall be held in Offline Mode.

The division of time is left to the discretion of the team members except for International Teams subject to the maximum of 12 minutes one speaker in the Preliminary round, 20 minutes in Semi-Final and 20 Minutes in the Final. In case any speaker continues to speak after the allotted maximum time, the additional time that has been used will be deducted from the time allotted to the other speaker and there will be some penalty marks also as per the discretion of the Judges.

Fictional Case in Public International Law

(1) Viria and Metulon are two states located on different continents, which have established diplomatic relations with each other, but their economic and trade relations are negligible. Both states are members of the United Nations and all of its specialized agencies, but not of other universal or regional international organizations. Both states have made a unilateral declaration, thereby recognizing the jurisdiction of the International Court of Justice. However, Viria's declaration contains a clause stating that "the International Court of Justice shall not have jurisdiction over matters within the internal jurisdiction of the State"

(2)The Khazori minority, which has lived in the territory of Viria for centuries and makes up about a third of the state's population, has long wanted to become independent. They currently have partial autonomy, which has manifested in cultural and language rights. They can use their own language in local administration but the central government has blocked the establishment of an ethnic Khazori political party via administrative obstacles. The Khazori minority's primary goal would be territorial autonomy and the creation of their own parliament, which, however, is explicitly forbidden by the constitution of Viria. In March 2024, a series of demonstrations began in settlements inhabited by Khazori, to which the central government responded with increasingly violent police action. As a result, a small group of Khazori became militarized and threatened the government of Viria with a series of terrorist attacks.

(3) In the summer of 2024, the Khazori held a self-organized referendum in parts of the country which they inhabit, in which 80% of the participants voted for secession, although only 45% of the voters took part in the referendum. The central government declared the referendum invalid, as it was organized by an unregistered party instead of the official authority who would have competence concerning the matter. Regardless, the Khazori declared secession, the establishment of an independent Khazaria, and the formation of their government, citing the results of the referendum supporting independence. The prime minister of the Virian government announced that he would never recognize the unconstitutional formation of the state and then mobilized Virian armed forces to suppress what they considered a "rebellion" and to hold accountable "those who committed crimes against the state." However, the Khazarian situation divided both the population of Viria and the military leadership. The latter did not want to resort to violence, so the armed forces stopped at the newly established border and did not penetrate Khazori territory.

The opinions of the UN member states are divided on the recognition of the new state. Metulon was among the first to recognize Khazaria, despite fierce protests from Viria. The head of state of Viria visited several states in the fall of 2024, trying to convince the leaders of the countries not to recognize the newly proclaimed entity as a state. However, when the plane of the head of state of Viria passed over Metulon airspace, the local air traffic control ordered the head of state's plane to land, claimingan impending security risk" without further specifying what it



Metulon authorities surrounded the plane with security personnel, did not allow the head of state to disembark, and also demanded that the plane be searched, which the head of state of Viria refused. Metulon authorities disregarded the protests and removed the packages from the plane, but did not open them, only using the scent of drugdetecting dogs and checked with a Geiger-counter that measures radioactive radiation. Under intense international pressure, the president's plane was finally granted permission to take off from Viria 24 hours after landing.

(5) Following the above incident, Viria initiated the contentious process of the International Court of Justice on 30 November 2024, requesting the court to declare that the measures taken by Metulon violated the customary international law norm of immunity of heads of state. On the same day, Metulon sent a note to the Secretariat of the International Court of Justice withdrawing its declaration accepting the Court's jurisdiction

Questions

- (1) To what extent did the Khazori people have the right to secede from Viria under international law? Can we consider what happened as a so-called remedial secession, and if so, why?
- (2) Describe the legal situation of Khazaria: was a new state established under international law? What legal consequences does this have for other countries?
 - (3) Was the immunity of heads of state violated by the actions of the Metulon authorities? Justify your answer!
- (4) Under what conditions can the jurisdiction of the International Court of Justice be established in the case regarding the violation of the immunity of heads of state as a norm of customary law?
