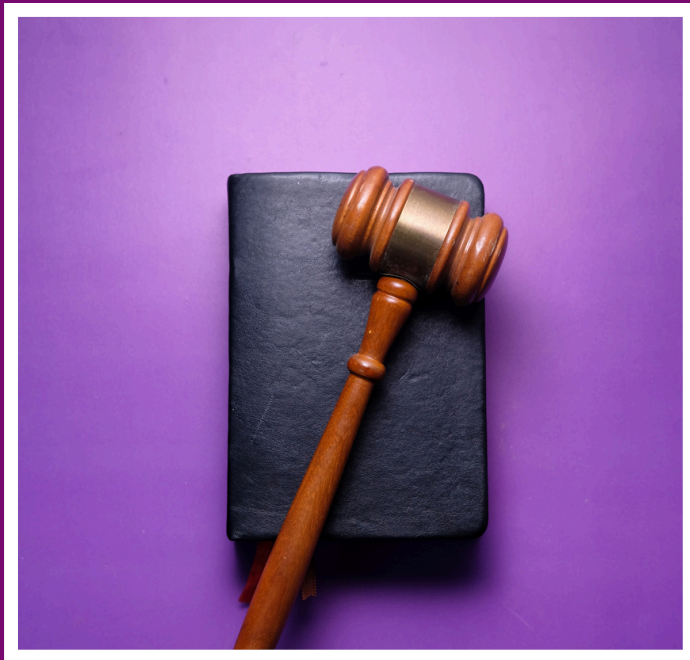

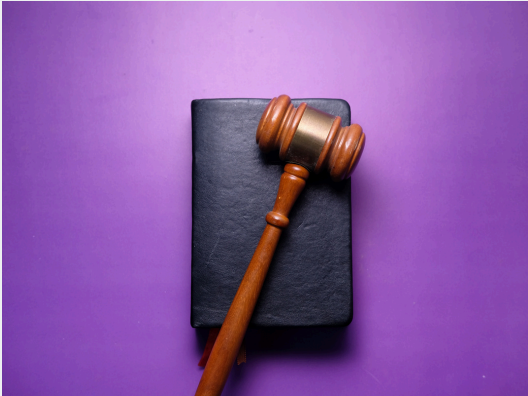

# Submission Guidelines

## Case Analysis Format

- ✓ Word Limit: 1,500 - 2,500 words (excluding references).
- ✓ File Format: PDF or Word, Font: Times New Roman, Size: 12, Line Spacing: 1.5.

### ✓ Structure:

- 1 Introduction – Brief overview of the case.
- 2 Facts of the Case – Key background details.
- 3 Legal Issues & Arguments – Main legal questions and arguments presented.
- 4 Court's Decision & Reasoning – Judgment and reasoning behind the ruling.
- 5 Critical Analysis & Conclusion – Personal insights, implications, and case significance.
- 6 References (if any) – Proper citations for sources used.

### ✦ Case Selection:

You can choose any national case from any country or an international case of your choice.

---

## Important Rules

- ✓ Original work only – plagiarism beyond 10% will lead to disqualification.
- ✓ Proper citations must be included if referring to sources.
- ✓ Submissions after the deadline will not be accepted.
