



## Call for Applications: PhD Students and Postdocs – Villa Vigoni Gespräch (16-19 June 2025, Lago di Como, Italy)

The **Villa Vigoni Gespräch** on “**Contracts and Characteristic Performance: Between Effect and Value**” will take place from **16 to 19 June 2025** at **Villa Vigoni, Lago di Como, Italy**.

The Organizing Committee is composed of Prof. Dr. Dr. Stefan Grundmann (Humboldt University and EUI), Prof. Dr. Valentina Calderai (University of Pisa), and Prof. Dr. Fabrizio Esposito (NOVA School of Law, Lisbon). A pool of internationally renowned scholars will participate in the event.

This event aims to explore a new **taxonomy of contracts** based on two descriptive variables—**legal effect** (exchange vs. organizational contracts) and **the type of value created for the creditor** (self-centered vs. relation-centered)—while pursuing the normative goal of **maximizing contractual value for the creditor of the characteristic performance**. The project challenges conventional contract law frameworks and seeks to refine the role of **characteristic creditor sovereignty** as a guiding principle.<sup>1</sup>

The **methodology** relies on a mix of formal consensus techniques, which are methods used in various contexts and most notably the medical profession and, recently the UK government,<sup>2</sup> aimed at collecting and synthesizing expert opinions. In light of the unique context of a three-day in-person meeting offered by the Gespräch, the organizers have decided to combine elements of a Delphi technique with elements of the nominal group conference.<sup>3</sup>

To prepare for the event, we are seeking applications from **PhD students and postdoctoral researchers** who are interested in engaging with these theoretical questions and contributing to the organization of the Gespräch.

We plan to invite five junior researchers to join the event. Accommodation and traveling expenses will be covered by Villa Vigoni (additional information will be provided).

Selected participants will:

- Review key preparatory materials and complete a **questionnaire** before the event (approx. 60-75 minutes)
- Assist in structuring and analyzing responses to the questionnaire
- Support the facilitation of discussions and structured surveys during the event
- Engage in high-level debates on contract law and its broader implications

We welcome applications from **motivated junior researchers** with an interest in **contract law, private international law, legal theory, and related fields**.

1. A **motivation letter** (max. 1 page) explaining how your research relates to the project
