# K.L. ARORA CHAIR ON CRIMINAL LAW

## ABOUT THE CHAIR

Justice D.P. Wadhwa former Judge, Supreme Court of India, the executor the Will of late Ms. Laj Bharti, sister of late Shri Kundan Lal Arora, Senior Advocate, as per her wishes, established a Chair in Criminal Law in the name of late Shri Kundan Lal Arora in National Law University Delhi with a view to promote teaching, research and advocacy in the field of Criminal Law.

### **ELIGIBILITY:**

- 1. LL.M. or relevant Masters degree in Social Sciences (Criminology/Psychology) from a recognised Indian or foreign university with minimum 55% marks (or an equivalent grade in a point scale wherever grading system is followed), and a good academic record.
- 2. For those applying with a relevant Masters degree in Social Sciences there must be a clear and demonstrable track record of interdisciplinary research involving law.
- 3. Proficiency in criminal laws is necessary.
- 4. Prior research experience including field work and data collection is desirable.

**REQUIREMENTS:** Demonstrable research track record in any one of the subjects mentioned in this call. Interdisciplinary research will be considered as an advantage.

### **ROLE & RESPONSIBILITIES OF ACADEMIC FELLOW:**

- 1. undertake to promote research in the field of criminal law, keeping in view the fast changes in criminal law both at national and international spheres and publish such papers in a journal which will be published annually;
- 2. organize seminars and conferences of national and international importance in criminal law;

- 2. Proficiency in criminal laws is necessary.
- 3. Prior research experience including field work and data collection is desirable.

- 6. The Chair shall provide an annual report of its activities related to the fit aching, research and advocacy goals of the Chair Professorship.

# ANNEXURE 'C'

# CHAIR ON INVESTMENT TREATIES AND INTERNATIONAL COMMERCIAL ARBITRATION

#### **ABOUT THE CHAIR**

Justice Indu Malhotra former Judge Supreme Court of India has setup a Chair on Investment treaty Arbitration "the Chair" at NLU Delhi.

The Chair has been instituted to carry out research and studies on complex issues emanating from the rising number of wide-ranging claims being made under International Investment treaties, with steering amounts being claimed towards damages and costs. Since the issue of entering into new investment treaties is the subject matter of consideration in India and also on the modes of dispute resolution, the primary object of the Chair is to carry out research and studies and introduce a Certificate course in Investment Treaty and Arbitrations arising therefrom, as also international commercial arbitrations, with a view to build capacity and expertise in this area of law within the country. The Chair shall support and encourage research on international commercial arbitration and investment treaty arbitration, including but not limited to:

- a) Drafting of Treaties whether investment related or trade specific, and principles of Treaty Interpretation.
- b) understanding various modes of dispute resolution such as state-state dispute settlement, investor-state dispute settlement between the host state and the foreign investor, issuance of joint interpretative statements, and various other modes of dispute resolution.
- c) reforms in the existing investor-state dispute settlement ("OSDS") system.
- d) international best practices in investment treaties
- e) the participants will learn to evaluate new trends in treaty practice, including discuss diverse modes of dispute resolution between foreign investors and host states
- f) Gain knowledge and skills relating to practical and procedural aspects relating to the conduct of arbitrations by various arbitral institutions, both in international commercial arbitrations, and investment treaty arbitrations.
- g) The Chair shall seek to contribute to policy development and capacity building on Investment Treaties and Dispute Resolution by participating in Policy Making on UNCITRAL Working Groups on Arbitration and ISDS and collaborate with other think tank organizations for this purpose.

#### **ELIGIBILITY:**

- 1. LL.M. from a recognised Indian or foreign university with minimum 55% marks (or an equivalent grade in a point scale wherever grading system is followed), and a good academic record.
- 2. Proven Proficiency in international commercial arbitration and investment.

3. Prior research experience including field work and data collection is desirable.

**REQUIREMENTS:** Demonstrable research track record in any one of the subjects mentioned in this call. Interdisciplinary research will be considered as an advantage.
