## ABOUT THE EVENT

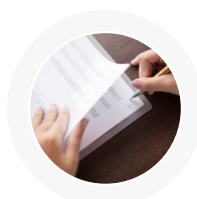

### PREPARATION

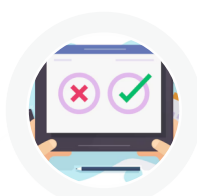
