- **Word Limit:** Up to 10,000 words
- **Abstract:** Approx. 150 words with 3–5 keywords (Should be part of the main manuscript)
- **Formatting:**
 - Font: Times New Roman, Size 12, Line spacing 1.5
 - Footnotes: Times New Roman, Size 10, Line spacing 1.0 (No Endnotes)
 - Use OSCOLA citation format
 - Headings:
 - **Level 1:** ALL CAPS & Bold
 - **Level 2:** First Letter Capital & Bold
 - **Level 3:** First Letter Capital, Bold & Italic
 - **Level 4:** Normal
- Include charts/tables/diagrams within the body of the manuscript and number them sequentially
- Submit in Microsoft Word format (docx.)
- Up to one co-author is permitted
- A brief author bio (200 words) will be required after acceptance
- Submission must be original, unpublished, and not under consideration elsewhere
- Strictly no plagiarism; papers will undergo editorial scrutiny.
- Zero tolerance against use of AI tools for drafting, etc..
