By fostering a dialogue, the program seeks to build capacity among legal educators to teach and research environmental justice in ways that emphasize sustainability, equity, and access.

Key themes include the convergence of criminal law with environmental justice, highlighting the criminalization of ecological harm, scope and access to Environmental Justice, climate change and legal accountability. Through expert lectures, interactive sessions, and assignments, participants will gain insights into integrating environmental justice using the help of criminal law to promote sustainability. This FDP ultimately aims to empower faculty members to contribute meaningfully to the discourse on sustainable development and environmental protection through the lens of criminal law.


