**2. Full Chapter Submission:**

- Word Limit: 4,000–8,000 words (excluding references)
- Formatting: APA 7th Edition or Publisher-Provided Template
- **Submission Deadline: August 15, 2025**

3. All submissions will undergo a double-blind peer review. Contributors must ensure originality and avoid plagiarism.

4. Maximum Two authors are allowed. The corresponding author (the one who will be in contact with the publisher during the proofing stage) needs to be highlighted using an asterisk symbol.
5. Permissible Similarity indexed - Turnitin report (under 10%). AI generated plagiarism shall also be less than 10%.
