APPLICATION PROCEDURE

To apply for the Legal Aid Award, follow these steps:

- Send your entries by filling this form: <https://forms.gle/dnTF5m8X88i6SMnx5>
- Entries must encompass activities carried out during the last year, from January 1st, 2024 to December 31st, 2024.
- Submissions should be accompanied by supporting documents, including photographs of camps or clinics conducted by the Legal Aid center, copies of registered complaints along with the provided solutions, or any relevant documentation that bolsters the event organized by the University/Colleges.

EVALUATION CRITERIA

- Legal Aid Clinics: Inside & outside the university/Colleges (05 marks for inside clinic and 10 marks for outside clinics per event).
- Legal Awareness Camps: Organized events will earn 10 marks each.
- Conference on Legal Aid or Human Rights or Social Justice: Gain 20 marks for international conferences and 10 marks for national conferences.
- Participate in this exceptional opportunity to showcase your contributions to the legal community and society at large. Submit your entries and supporting documents before the deadline to be considered for the Legal Aid Award.

Please Note: The evaluation process is subject to the discretion of the Knowledge Steez award committee. Make sure to adhere to the provided guidelines and deadlines for a successful application.
