LEGAL AID EDUCATIONAL FAIR-2025 : EVENTS

MOCK TRIAL COMPETITION

REGISTRATION FEES – INR 500/- PER GROUP

- Mock Trial will be conducted on 22nd & 23rd August, 2025.
- All the participants have to report at 9 A.M sharp.
- All participants are required to carry their Institution ID Cards which they have to show at the registration desk for the verification.

ELIGIBILITY:

- All students duly enrolled and pursuing a full-time 3-year LL.B. program or a 5-year integrated LL.B. program from the Institution/University recognized by the Bar Council of India shall be eligible to participate in the competition.

TEAM COMPOSITION:

- Each team shall consist of 2 members.

DRESS CODE:

- For Boys – Formal Attire (White shirt, black trousers, black tie, black blazer and black shoes)
- For Girls - Formal Attire (White shirt with trousers with a black coat and black shoes / white Kurti, Salwar with a black dupatta)

MODES OF COMMUNICATION:

- ENGLISH ONLY

WITNESS:

- Organizers will provide the witnesses.
- The witnesses will be assigned and briefed by the Organizers. However, each team will have an opportunity to brief their witnesses.
- To maintain impartiality and transparency a team shall not be assigned same witnesses in two different rounds.
- Surprise Witnesses acting as “court witnesses” may be introduced at any time during the proceedings.
- It is not mandatory for the teams to examine all the witnesses. However, a minimum of 2 witnesses have to be examined in each round.

RULES AND REGULATIONS:

- Team code shall be provided to each team.
- Teams should not disclose their identity at any point of time during the Competition.
- Such disclosure shall invite penalties including disqualification.
- In case of any misconduct during the competition, the Organizer reserves the right to disqualify the participants.
- All team members, coaches, advisors, and observers shall be refrained from identifying a team’s college at any time (during the competition) and in any manner, including but not limited to wearing any identifying items (such as college clothing, ties, patches or pins) or carrying identifying material (such as books with a college logo or college seal, etc.)

COMPETITION STRUCTURE:

WRITTEN BRIEF:

- All the teams whose participation has been confirmed by the organizers will have to submit 6 hard copies of the written brief from both sides (petitioner-3, respondent-3; in total 6 copies) neatly bound with Spiral binding.
- Soft copies of the MEMORIALS should reach the organizers BY 11:59 p.m. ON 20TH August, 2025.

WRITTEN SUBMISSION GUIDELINES:

- Teams have to prepare memorials for both the prosecution and the defence.
- The colour code for the written brief/memorials for PROSECUTION is BLUE and for DEFENCE is RED.
- The memorials have to be submitted on A4 size paper.
- The memorials must be printed in Times New Roman font with 12 font size and with 1.5 line spacing.
- The footnotes must be in Times New Roman font with 10 font size and with 1.0 line spacing. The memorials should have a margin measuring one inch on all sides of each page. And should contain the 'Team Code' on the cover page. (Top-Right Corner).
- Teams shall cite authorities in the Memorial using footnotes following the Harvard Bluebook 20th Edition and the footnoting must be uniform throughout the Memorial.
- The teams should submit the memorials in both word and PDF format in the given link below.

ORAL ROUNDS:

At the time of the draw of lots, the teams are required to go through the following procedure:

- Serving of Copies (at the time of written submissions).

There shall be 3 oral rounds –

1. PRELIMINARY ROUND
2. SEMI FINAL ROUND
3. FINAL ROUND

PRELIMINARY ROUND 45 Minutes:

Detailed time slot for preliminary round:

- Opening Statement on behalf of the Prosecution- 2 minutes
- Opening Statement on behalf of the Defence of– 2 minutes
- Examination-in-Chief on behalf of the Prosecution – 4 minutes.
- Cross-Examination on behalf of the Defence – 8 minutes.
- Examination-in-Chief on behalf of the Defence – 8 minutes.
- Cross-Examination on behalf of the Prosecution – 8 minutes.
- Final Arguments on behalf of the Prosecution – 8 minutes
- Final Arguments on behalf of the Defence – 5 minutes

1. Each speaker shall have to conduct either of the two examinations and deliver either the opening statement or the final argument in each round.
2. The combination each team would like to follow needs to be informed to the organizers at the time of the orientation and the same shall not be altered for any of the later rounds.

In the Semi-Final and the Final round, the time slot shall be (1 hour 10 minutes)

- Opening statement on behalf of the Prosecution – 5 minutes.
- Opening statement on behalf of the Defence – 5 minutes.
- Examination-in-Chief on behalf of the Prosecution – 10 minutes.
- Cross-Examination on behalf of the Defence – 10minutes.
- Examination-in-Chief on behalf of the Defence – 10 minutes.
- Cross-Examination on behalf of the Prosecution – 10 minutes.
- Final Arguments on behalf of the Prosecution – 10 minutes.
- Final Arguments on behalf of the Defence – 10 minutes.

Note: The guidelines for the memorials submission must be strictly followed

- Legal Aid Simulation Camp Competition will be conducted on 22nd August, 2025.
- All the participants have to report at 12:30 P.M.
- All participants are required to carry their Institution ID Cards which they have to show at the registration desk for the verification.

ELIGIBILITY:

- All students duly enrolled and pursuing a full-time 3-year LL.B. program or a 5-year integrated LL.B. program from the Institution/University recognized by the Bar Council of India shall be eligible to participate in the competition.

TEAM COMPOSITION:

- Team should consist of 2 to 6 members.

CONCEPT NOTE:

Legal Aid Committee of Birla School of Law is organising a Legal Aid Simulation Camp in the community hall of Nyayapur, where villagers of Nyayapur are expected to come and seek redressal of their grievances. The participants will act as a lawyer and will give legal advice to the concerned villagers. The competition will simulate real-world legal aid scenarios.

GUIDELINES / RULES AND REGULATIONS:

- The topics will be assigned to the participants 1 hour before the competition
- Each team shall address the gathering on the allotted topic for 15 minutes, followed by grievance redressal session for 20 minutes.
- Each team member is expected to participate actively.
- Participants must maintain confidentiality regarding case details during the competition.
- Use of Mobile phones and any electronic items will lead to disqualification.
- Professional decorum must be maintained during the competition.
- Judges' decisions shall be considered as final and binding.

 2. Family Law
 3. Property Law

ELIGIBILITY:

- Students pursuing any type of UG course from any institution/ university/ college.
- More than one team can participate from the same institution.

TEAM COMPOSITION:

- 8 to 12 members

GUIDELINES / RULES AND REGULATIONS:

- Maximum time - 12 minutes.
- There will be negative marking if teams exceed the performance time.
- Teams using any props are required to get their own props and be ready on time as per instructions of the organizer.
- The competition will be conducted on a “ground” like (open place).
- Decision of Judges shall be final and binding.
- The organizer will allot a team code to every team and teams will be addressed by only their team code during the competition.
- The participants are strictly prohibited to disclose their identity throughout the competition. Any such disclosure of identity will result in disqualification.
- Teams should maintain decency and decorum in their behaviour, attire and performance throughout the competition.

- Any kind of fluids, animals, flames, heavy objects, colours or any other material which has a possibility of damaging the venue is strictly prohibited. Using the same may result into disqualification.
- Any Obscenity during the play is not allowed and may lead to disqualification, upon the discretion of judge.
- No Time for rehearsal / Stage practice / final rehearsal will be given before the competition.
