## About HPU

Established by an Act of the Legislature on 22<sup>nd</sup> July, 1970, it is the only multi-faculty residential and affiliating university in the State that provides higher education to urban, rural and tribal areas through formal and distant mode. **Established in June, 1989** formerly known as **Human Resource Development Centre (HRDC)** has been renamed as **Malaviya Mission Teacher Training Centre (MMTTC)** of Himachal Pradesh University. This Centre conducted its **First Orientation Programme in September 1989**. It has pursued the objective of improving the professional competence of teachers in tertiary education with a difference. By the end of March 2024, it has **organized 530 programmes, 133 Orientation Programmes, 11 Faculty Induction Programmes (FIP), 338 Refresher Courses and 54 SSS/SWS/STC & Webinars in which 18418 teachers have participated**
