For Paper Presenters:

- Each paper presenter will be allocated 10–12 minutes for presentation and 3–5 minutes for Q&A.
- Presenters are advised to briefly introduce their topic, highlight key findings or arguments, and conclude with implications or recommendations.
- Presenters are required to report to their assigned rooms at least 15 minutes before the start of their session

4. Abstract Submission:

The upcoming conference invites submissions that delve into the evolving intersection of law and other disciplines. Scholars, researchers, and practitioners are encouraged to explore how legal thought adapts, responds to, and shapes a rapidly changing, cross-disciplinary world. Each applicant must submit an abstract of **200–300 words** providing a clear overview of their proposed paper. - Critical evaluation of current laws and systems
- Proposals for legal reform within a multidisciplinary framework
