- Decision of the Editorial Board on all matters shall be final.
- **Only the authors of selected abstracts will be required to make the payment of registration fees.**

SUBMISSION GUIDELINES

Abstract Submission

- Each applicant must submit an abstract of **300 words** with **4 keywords** providing a clear overview of their proposed paper. It must include research methodology and main objective of the paper and conclusion.
- Abstracts should be submitted by **30/11/2025** via **email to usllsconference.2026@gmail.com**.
- Notified abstracts will be informed within 10 days of last date of submission.

Submission of Final Papers: Authors whose abstracts are accepted are invited to submit a full paper adhering to the following guidelines:

- **Word Limit**

The paper should not be less than 6000 words.

- **Format Requirements**

Font: Times New Roman, **Size:** 12pt, **Alignment:** Justified and, **Line spacing:** 1.5

- **Citation Style**

The paper should follow the **ILI rules** of footnoting.

Font: Times New Roman, **Size:** 10pt, **Alignment:** Justified and, **Line spacing:** 1.
