

Genesis



ORGANIZING COMMITTEE

1. ADMINISTRATION

The 2nd NMIMS Moot Court Competition, 2026, will be organized and hosted by SVKM's NMIMS School of Law, Chandigarh Campus, India. This offline competition will take place on 13th-14th March 2026.

The position of faculty convenors for the 2nd NMIMS MCC 2026 are held by Dr. Sonia Grewal Mahal, Assistant Professor (School of Law), Dr. Shefali Singh, Assistant Professor (School of Law); and Dr. Muzaffar Mir, Assistant Professor, (School of Law). The Organizing Committee, acting under the authorization of the Moot Court Committee of NMIMS, Chandigarh Campus will handle all tasks related to the management and smooth execution of the competition.

2. LANGUAGE

The official language for all oral and written submissions throughout the competition will be English. All participants must adhere strictly to this rule.

3. STRUCTURE OF THE COMPETITION

The competition will not consist of Memorial Elimination and 30 teams will be selected on first come first served basis. The said teams will participate in the oral rounds, which will include Preliminary Rounds and Advanced Rounds i.e. - Quarterfinals, Semifinals, and the Finals.

4. INTERPRETATION OF RULES

The Organizing Committee will have the sole authority to interpret the rules of the competition in the event of any ambiguity, conflict, or dispute. Any interpretation will prioritize fairness and equity, and the decisions of the Committee regarding the application of these rules will be final and binding on all participants.

ELIGIBILITY & PARTICIPATION

5. ELIGIBILITY

The Competition is open to students currently enrolled in LL.B. Degree Courses (3 year/5 year). Each participating team must represent only one institution, and no institution will be allowed to register more than one team. In case the Institution has more than one campus, then a team each can represent the campus.

6. TEAM COMPOSITION

- a. A team is required to have three members, consisting of two speakers and one researcher.
- b. After the registration deadline, any substitution of team members will only be permitted under exceptional circumstances and with prior approval from the organizers.

7. REGISTRATION

- a. Teams must register by completing the designated registration form. The registration link is here:
- b. Each team must designate one member as the Point of Contact (POC), who will be responsible for receiving and sharing all communications related to the competition.

- c. Upon submission of the registration form, a provisional confirmation email will be sent to the respective institution.
- d. Registration will only be considered complete once the registration fee has been paid.
- e. All registration formalities must be completed by **07.02.2026**.
- f. Teams will be assigned a unique Team Code, which must be used for identification throughout the competition.
- g. Disclosing the institution's identity in any form during the competition is strictly prohibited and may lead to penalties or disqualification as determined by the faculty convenors of 2nd NMIMS MCC 2026.

8. PAYMENT OF REGISTRATION FEE

The registration fee for the competition is as follows:

INR 4500/- (inclusive of GST) for teams without accommodation

The fee is payable through online bank transfer. Proof of payment must be attached to the registration form.

9. CONFIRMATION OF PARTICIPATION

The first 30 teams, based on the time of confirmation of their payment, will receive an email confirming their participation. Teams must confirm their participation by **07.02.2026**; failing this, invitations will be extended to the next teams in line.

CLARIFICATIONS

10. CLARIFICATION PROCESS & DEADLINES

Teams may submit queries related to the moot proposition via the provided Google Form link. A team may submit a maximum of 3 queries. The deadline for submitting queries is 11:59 PM IST on **09.02.2026**.

The clarifications will be released on **13.02.2026**.

MEMORIAL EVALUATION ROUND

11. MEMORIAL SUBMISSIONS

- a. All registered teams must prepare two memorials: one for the Petitioner(s) and one for the Respondent(s).
- b. Memorials must be submitted via email to Sol.mootcourt@nmims.edu by 11:59 PM IST on **23.02.2026**. The email subject must read: "Memorials (Team Code) – 2nd NMIMS Moot Court Competition, 2026 Chandigarh.
- c. A penalty of 1 point per hour will apply for late submissions. Memorials submitted more than 12 hours after the deadline will not be evaluated.
- d. Teams cannot modify or resubmit memorials after submission.

12. MEMORIAL FORMAT

- a. Memorials must be submitted as Microsoft Word documents (.doc/.docx). Teams may additionally submit a PDF version but not as a standalone document.
- b. The file name for each memorial must follow this format: “Team Code + P (Petitioner)” or “Team Code + R (Respondent).” Therefore, if a team is given Team Code 7, then their submissions for petitioner and respondent should be titled 7P and 7R respectively
- c. Formatting requirements:
 - Legal-sized pages, 1-inch margins on all sides.
 - Times New Roman font, size 12, with 1.5-line spacing for text and size 10 with single-line spacing for footnotes.
 - Footnotes must be in 20th Edition of the Bluebook throughout the memorial
- d. Plagiarism
 - Plagiarism of more than 20% will attract a penalty of 1 point, on every 5% plagiarism.
 - Plagiarism of more than 50% will lead to disqualification of the team.

13. MEMORIAL CONTENT

- a. Each memorial must include the following sections:
 1. Cover Page
 2. Table of Contents
 3. Table of Abbreviations
 4. Index of Authorities
 5. Statement of Jurisdiction
 6. Statement of Facts
 7. Issues Raised
 8. Summary of Arguments
 9. Arguments Advanced
 10. Prayer
- b. The Arguments Advanced section should not exceed 30 pages, and the memorial must not exceed 50 pages, including the cover page. Non-compliance will attract penalty of 1 point per page for every page exceeding the limit of 50 pages.
- c. Citations must adhere to the 20th Edition of the Bluebook. Speaking footnotes and endnotes are prohibited.

14. MEMORIAL EVALUATION

Memorials will be scored out of 100 marks. Detailed evaluation criteria and points allocation shall be as follows:

ORAL ROUND PROCEDURE

15. GENERAL PROCEDURE

- a. The oral rounds will be held in person at the NMIMS Chandigarh Campus and will consist of the following:
 - Preliminary Rounds
 - Quarter final Round
 - Semi-final Round
 - Final Round
- b. The preliminary stage will have two rounds: Preliminary Round I Preliminary Round II In each round, the team representing the Petitioner(s) will present their arguments first, followed by the Respondent(s). After the arguments are completed, rebuttals by the
- c. Petitioner(s) and sur-rebuttals by the Respondent(s) may be permitted at the discretion of the judges. Participants must refer to themselves using their designated Team Code during all proceedings and are strictly prohibited from disclosing their institution's identity. Draw of Lots and Memorials will be exchanged between competing teams after the
- d. inaugural ceremony for the preliminary rounds. For subsequent rounds, memorial exchanges will occur well in advance as determined by the Organizing Committee.

e. PROCEDURES FOR ORAL SUBMISSIONS

Teams may divide their allotted time among their speakers at their discretion
 Teams must inform the judges about their time division, including the allocation for rebuttals (Petitioner) or sur-rebuttals (Respondent), before the commencement of the

- c. Arguments presented must strictly adhere to the issues outlined in the submitted memorials.
- d. Researchers must be present during oral rounds.
- e. Participants are required to wear formal courtroom attire.
- f. Compendiums are optional but must be submitted in PDF format if used. These must include only the first page and relevant sections of any cited document or case. An index must be included at the beginning of the compendium file, and the file name must follow the format: C- 'Team Code'-Side (e.g., C10R for Respondent).
- g. The Organizing Committee will not be held responsible for any difficulties judges may encounter in locating documents within the compendium.
- h. Each speaker will be evaluated on a scale of 100 marks by each judge. The evaluation criteria will be as follows:

- i. The decision of the judges with regard to the outcome of the rounds shall be final.

17. PRELIMINARY ROUNDS

- a. There shall be two preliminary rounds. Each team shall argue in both the rounds, once as Petitioner(s) and once as Respondent.
- b. No team shall face the same bench more than once in the preliminary rounds.
- c. Each team will have 20 minutes to present their case during the preliminary rounds.
- d. The top 8 teams on the basis of aggregate score of both Preliminary Rounds and Memorial Evaluation will advance into the quarter finals

18. QUARTER FINALS

- a. The top 8 teams with the highest cumulative scores from the preliminary rounds will advance to the quarter finals.
- b. In the event of a tie, memorial scores will be used to determine the qualifying teams.
- c. Match-ups for the quarter finals and the side allotted to each team will be determined through draw of lots.
- d. Each team will have 20 minutes to present their case during the quarter finals rounds.
- e. This will be a knock out round

19. SEMI FINALS

- a. The winners of the quarterfinal rounds will advance to the semi-finals.

- b. Match-ups for the semi-finals and the side allotted to each team will be determined through draw of lots.
- c. Each team will get 30 minutes to present their case during semi-finals
- d. This will be a knock out round

20. **FINALS**

- a. The winners of the semi-final rounds will compete in the final round.
- b. The side each team argues on will be determined through a draw of lots.
- c. The final rounds will comprise a total of 40 minutes.
- d. The team that wins the final round will be declared the overall winner of the Competition.

RESEARCHER'S TEST

21. **GUIDELINES FOR THE RESEARCHER'S TEST**

- a. The researcher's test will evaluate participants based on their knowledge of the moot proposition, legal principles, and research skills.
- b. The participant with the highest score in the researcher's test will receive the **Best Researcher** award.

MISCELLEANEOUS

22. **AWARDS**

- a. The winning team will receive a cash prize of INR 21,000.
- b. The runners-up team will receive a cash prize of INR 15,000.
- c. The Best Speaker will receive a cash prize of INR 5,000
- d. The Best Speaker (Runners Up) will receive a cash prize of INR 3,000
- e. The team with the Best Memorial will receive a cash prize of INR 5,000.
- f. Best Researcher will receive a cash prize of INR 5,000.
- g. All participating teams will be provided with a certificate of participation or a certificate of merit, in accordance with the performance of the team.

23. **SCOUTING**

- a. Teams that have been eliminated from the competition may observe oral rounds, but no team still competing is allowed to observe another round.
- b. Scouting of other teams is strictly prohibited and will result in immediate disqualification.


24. **ANONYMITY**

- a. Teams must use their designated Team Code for identification at all times.
- b. Any violation of this rule will lead to immediate disqualification, and the decision of the Organizing Committee shall be final.

25. **ORGANIZING COMMITTEE COMMUNICATION PROTOCOL**


- a. The Organizing Committee reserves the right to amend or modify the rules at any stage of the competition

Between

Association of Academic Publishers of Jenria v. Union of Jenria

Part I

1. The Republic of Jenria (hereafter Jenria) is a welfare state with federal structure founded on the egalitarian principles of equality for all and non-discrimination. Since its independence in the mid-20th century, Jenrian policy has been to adopt an inclusive approach to public utilities, including food, infrastructure, and education. Constitutionally, the Government of Jenria is obligated to ensure that the community's resources serve the common good and that economic policies are so framed as not to lead to the concentration of wealth or the means of production.
2. The Government of Jenria is promoting healthy economic activities, including those that promote a knowledge-based economy. In 2016, it adopted a National Intellectual Property Rights Policy, realising 'the need to build respect for IPR among the general public and to sensitise the inventors and creators of IP on measures for protection and enforcement of their rights'.
3. In September and November 2023, two separate incidents happened in Kaspot, Jenria's capital, that brought back the debate of accessible education in higher educational institutions of Jenria into the public spotlight.
4. In the first instance, a law student Ms. Ritika, studying at the University of Kaspot, was stopped from getting select chapters of a law book photocopied within the university premises because the administration believed that it would lead to the triggering of a legal suit by the publisher against the university. Ritika retorted by saying that because the library has a single copy of the highly priced book, students have no option but to get it photocopied. When the matter received media hype, the book publisher issued a public statement praising the university for respecting the publisher's exclusive rights to commercially reproduce the material.
5. In the second instance, the President of the Visually Impaired Students Network (VISNET)- Mr. Pradeep gave an interview to the national newspaper The Jenria Express,

highlighting the plight of visually impaired persons (VIPs) in Jenria, especially those who seek to gain knowledge and do good for themselves and their community. His complaint about access to copyrighted material for VIP students studying in higher educational institutions caught the general attention. According to Pradeep, technological locks, licensing restrictions and unavailability of accessible formats such as Braille or DAISY for VIP students were major obstacles in their educational aspirations. Some local vendors provided unauthorised access to academic material in VIP friendly format. But the services stopped after they received legal notice from the Jenrian offices of two international publishers- Kabrige University Press and Yoford University Press. Pradeep expressed sadness on this development because these so-called ‘unauthorised’ vendors were, in reality, critical education access points for VIP students.

Part II

6. The Inclusive Knowledge Cohort (hereafter IKC) is a registered society based in Kaspot. It advocates for accessibility and the rights of persons with disabilities, ensuring that vulnerable groups are not left out of Jenria's post-independence growth story. With the foregoing incidents in the background, IKC published an empirical study in June 2024 titled 'A Status Report on Affordable Access Opportunities for University Students'. The study included 2000 students from five public universities in Kaspot with financial and/or visual impairment vulnerabilities.
7. The Status Report found that a majority of the academic or research material was not easily available in accessible formats for VIPs. It was also reported that 85 per cent of middle-class and lower-middle-class students at universities had insufficient access to books due to either unavailability, limited digital database or high prices. Even when books were available in libraries, the numbers were insufficient to meet the needs of students.
8. These findings gained immediate media traction and became part of the public discourse. The ruling government (People’s Welfare Party) did not want to take any risk that could lead to diminished electoral dividends in the impending parliamentary elections in early 2026. Therefore, the Union Minister of Law and Justice in Jenria, Mr. Ahlawat, held a press conference in January 2025 and proclaimed that the government is going to table a

bill titled 'Facilitation of Equitable Access to Knowledge in Higher Educational Institutions Bill of 2025' to address the issue of accessibility to the copyrighted material for higher education students coming from vulnerable backgrounds. This bill would broadly propose:

- i. active usage of compulsory license and fair dealing provisions in the Copyright Act, 1957 in the academic field,
- ii. authorisation of designated agencies for disseminating VIP friendly educational material, and
- iii. establishment of the Jenrian Reprographic Rights Council modelled on a copyright society, for the purpose of granting licenses to perform a photocopy of copyrighted publications with a minimum royalty.

Part III

9. Association of Academic Publishers of Jenria (AACAP) is a representative group of publishing houses operating in Jenria. Kabrige University Press and Yoford University Press have a significant influence on AACAP's operations through their offices in Jenria. Several other publishing companies, primarily from the USA and Europe but legally operating with subsidiaries in Jenria, are also members of AACAP.

10. In February 2025, AACAP took note of the aforementioned proclamation of the law minister and released a common statement of understanding, which read as follows:

The proposal of Facilitation of Equitable Access to Knowledge in Higher Educational Institutions Bill of 2025 misreads the copyright law and runs contrary to Jenria's domestic and international obligations, in particular the "Three Step Test" articulated in the Berne Convention for the protection of Literary and Artistic Works (hereinafter referred to as "the Berne Convention") and The Agreement on Trade-Related Aspects of Intellectual Property Rights (hereinafter referred to as "the TRIPS"). It renders copyright infructuous, impinges upon the freedom to trade and makes it impossible for academic and educational publishers to function in Jenria, as their primary market (educational institutions and students) would be devastated.

11. Just two months after these developments, in April 2025, the United States Trade Representative (USTR) published its annual Special 301 Report. Jenria usually features in the "priority watch list" of the Report as the worst IP "performers" among the TRIPS signatories. This time in the 2025 Report, it was again put in the spotlight for not fully

implementing WIPO Internet Treaties and falling short of international best practices, including with respect to technological protection measures and right management information. The Report took into account the AACAP statement raising the concerns regarding the potential abuse of compulsory licensing, commercial-scale photocopying and unauthorised reprints of academic books, and circumvention of technological protection measures to arm-twist reputed publishers into providing accessible formats for the disabled.

12. Regardless, the spokesperson of the Government of Jenria retorted by emphasising that the available flexibilities within the international and domestic copyright regime give enough scope to the government to carve out such exceptions and ensure adherence to its constitutional obligations. With the signing and ratification of the Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired or Otherwise Print Disabled, 2013, and with its own disability rights-related laws, the government cannot turn a blind eye to social realities and constitutional obligations.

13. Despite AACAP's discontent, the parliament passed the Facilitation of Equitable Access to Knowledge in Higher Educational Institutions Act in October 2025. It is now up for challenge before the Supreme Court of Jenria under a writ petition brought by AACAP, claiming that in addition to disrupting the existing copyright regime, the law is discriminatory, arbitrary, violates the freedom of expression of authors and is detrimental to the freedom to carry on legitimate trade or business.

14. Issues framed by the Court are as follows:

- i. Whether the writ petition is maintainable?

- iii. Whether Jenria is legally entitled to create enabling exceptions in copyright law for VIPs and university students?
