- **Round 1:** Qualifying/Assessment Round
 - **Round 2:** Elimination Round
1. Scores of **Round 1 and Round 2 shall be accumulated.**
 2. On the basis of cumulative score, **Top Three (3) Teams** shall become eligible for **Round 3 – the Final Round.**
 3. Only the finalists of top 3 teams will participate in the final round.
