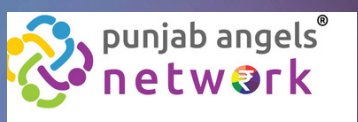

## Paper Submission Guidelines

Academicians, industry experts, research scholars, and students are invited to contribute papers on topics related to the conference theme. All paper submissions will be subjected to a double-blind peer review. The reviewers' decision will be final and binding. To facilitate the review process, the author should adhere to the prescribed guidelines.

Abstract should not exceed 500 words and should contain the title of the paper, authors' & co-author names, institutional affiliations, abstract and keywords (up to 5). The maximum full paper length (excluding tables, figures and references) should not exceed 5000 words. The paper should be in Times New Roman, Font Size 12, with 1.5 line spacing. Authors should follow the APA (Seventh Edition) style of referencing. Plagiarism should not exceed 10% to maintain the originality of the manuscript.
